

2. Location: Iowa Insurance Division (Lobby Conference Room), 330 Maple, Des Moines, Iowa.
3. Nature of Hearing: The hearing will be a public opportunity for the Applicant and any other interested party to present evidence and argument relevant to the Plan of Reorganization. Applicable rules of evidence are found at Iowa Code section 17A.14 (2011).
4. Legal Authority: The hearing will be held pursuant to Iowa Code section 521A.3(4)(b) (2011). Procedures for the hearing are found at Iowa Code section 17A.12-17 (2011).
5. Issue Presented: The hearing will be held to determine whether the Applicant's Plan of Reorganization complies with the standards set forth in Iowa Code section 521A.14.
6. Statutes and Rules Involved: Iowa Code chapters 17A and 521A (2011), and 191 IAC chapter 46.
7.
