This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Human Services ("DHS"). Under Iowa Code section 252J.8 (2015) and Iowa Administrative Code, rule 191-10.21, the Iowa Insurance Commissioner was required to issue a notice to **Douglas R. Allen** ("Respondent") advising the Respondent that the Certificate of Noncompliance was received and that the Respondent's Iowa insurance producer license would be suspended in 30 days unless DHS withdrew the Certificate of Noncompliance within those 30 days. The Iowa Insurance Division's letters notifying the Respondent of the intended suspension were sent on May 28, 2015.

Therefore, the thirty-day notice period has now passed and DHS has not withdrawn the Certificate of Noncompliance. The Iowa Insurance Commissioner has authority to order the suspension of the insurance producer license of the Respondent pursuant to Iowa Code section 252J.8 (2015) and Iowa Administrative Code, rule 191-10.21.

IT IS THEREFORE ORDERED that:

The Iowa insurance producer license of **Douglas R. Allen** is suspended as of the date of this Order.
