Certificate of Noncompliance from the Iowa Department of Human Services ("DHS"). Under

Iowa Code section 252J.8 (2015) and Iowa Administrative Code, rule 191-10.21, the Iowa

Insurance Commissioner was required to issue a notice to Jason E. Will ("Respondent")
