

Pursuant to Iowa Code chapter 522B and IAC 191-10.10, this matter comes before the Commissioner of Insurance upon an application by Lord Stephen A. Range for the reinstatement of his Iowa insurance producer's license.

I. PARTIES AND JURISDICTION

1. The Commissioner of Insurance, Nick Gerhart, directly and through his designees, administers and enforces the provisions of Iowa Code § 505.8 and the Iowa Licensing of Insurance Producers Act, Chapter 522B.

2. Lord Stephen A. Range ("Range") is an individual with a last known mailing address of 1420 1st Ave. NE, Ste. #203, Cedar Rapids, IA 52402 and a national producer number of 16389652.

3. Range has filed an application with the Iowa Insurance Division ("Division") for reinstatement of his suspended license and the Commissioner is authorized to issue this Order pursuant to 191 IAC 10.10.

II. FINDINGS OF FACT

4. Range is licensed as a resident insurance producer in the State of Iowa.

5. Range submitted an application for individual insurance producer license on September 15, 2011, in which the Commissioner was designated as agent for service of process.

6. On December 11, 2015, the Division mailed Range notification of the intent to issue a suspension of his license if the Iowa Department of Human Services ("DHS") did not withdraw the Certificate of Noncompliance within 30 days.

7. On March 31, 2016, an order was issued by the Division immediately suspending Range's insurance producer's license ("Suspension Order").

8. DHS withdrew the Certificate of Noncompliance on April 1, 2016.

9. On April 21, 2016, Range filed an application for reinstatement after suspension of his insurance producer license as required by 191 IAC 10.10.

10. As Range has complied with the condition of the Suspension Order and filed the necessary reinstatement application, an order of reinstatement of his Iowa insurance producer's license should be issued.

III. CONCLUSIONS OF LAW

1. Iowa Code § 522B.11(1) authorizes a range of disciplinary actions for insurance producers, including suspensions, but the imposition and duration of suspensions, is within the discretion of the Commissioner.

2. Range is in compliance with the conditions of the Suspension Order issued on March 31, 2016 and has filed the required application of reinstatement. An order of reinstatement should be issued pursuant to 191 IAC 10.10.

IV. ORDERS

IT IS THEREFORE ORDERED that:

A. The Suspension Order issued on March 31, 2016 is hereby vacated and the Iowa

resident insurance producer license of Range is reinstated; and

B. Range shall immediately be able to transact and participate in the business of insurance in Iowa.

IT IS FURTHER ORDERED that, pursuant to Iowa Code § 505.8(10), the one hundred dollar (\$100) payment made with the application for reinstatement shall be paid to the Iowa Insurance Division settlement fund established for recovery of expenses and costs related to investigations and other proceedings.

ORDER FOR SUSPENSION

This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Human Services ("DHS"). Under Iowa Code section 252J.8 and Iowa Administrative Code, rule 191-10.21, the Iowa Insurance Commissioner was required to issue a notice to **Lord Stephen A. Range** ("Respondent") advising the Respondent that the Certificate of Noncompliance was received and that the Respondent's Iowa insurance producer license would be suspended in 30 days unless DHS withdrew the Certificate of Noncompliance within those 30 days. The Iowa Insurance Division's letters notifying the Respondent of the intended suspension were sent on December 11, 2015. Therefore, the thirty-day notice period has now passed and DHS has not withdrawn the Certificate of Noncompliance. The Iowa Insurance Commissioner has authority to order the suspension of the insurance producer license of the Respondent pursuant to Iowa Code section 252J.8 and Iowa Administrative Code, rule 191-10.21.

IT IS THEREFORE ORDERED that:

The Iowa insurance producer license of Lord Stephen A. Range is suspended as of the date of this Order.
