Pursuant to Iowa Code chapter 522B and 191 IAC 10.10, this matter comes before the Commissioner of Insurance upon an application by Chad C. Arey for the reinstatement of his Iowa insurance producer's license.

## I. PARTIES AND JURISDICTION

- 1. The Commissioner of Insurance, Nick Gerhart, directly and through his designees, administers and enforces the provisions of Iowa Code § 505.8 and the Iowa Licensing of Insurance Producers Act, Chapter 522B.
- 2. Chad C. Arey ("Arey") is an individual with a last known mailing address of 1521 E. 22nd St., Des Moines, IA 50317.
- 3. Arey has filed an application with the Iowa Insurance Division ("Division") for reinstatement of his suspended license and the Commissioner is authorized to issue this Order pursuant to 191 IAC 10.10.

## II. FINDINGS OF FACT

- 4. Arey is licensed as a resident insurance producer in the State of Iowa.
- 5. Arey submitted an application for individual insurance producer license on October 6, 2003, in which the Commissioner was designated as agent for service of process.

- 6. On December 11, 2015, the Division mailed Arey notification of the intent to issue a suspension of his license if the Department of Human Services ("DHS") did not withdraw the Certificate of Noncompliance within 60 days.
- 7. On March 21, 2016, a suspension order was issued by the Division immediately suspending Arey's insurance producer's license ("Suspension Order"). Arey was also notified that the Division's reinstatement of the producer license was contingent upon DHS withdrawing the Certificate of Noncompliance.
  - 8. DHS withdrew the Certificate of Noncompliance on April 26, 2016.
- 9. On April 26, 2016, Arey filed an application for reinstatement after suspension of his insurance producer license as required by 191 IAC 10.10.
- 10. As Arey has complied with the suspension and filed the necessary reinstatement application, an order of reinstatement of his Iowa insurance producer's license will be issued.

#### III. CONCLUSIONS OF LAW

- 1. Iowa Code §522B.11(1) authorizes a range of disciplinary actions for insurance producers, including suspensions, but the imposition and duration of suspensions, is within the discretion of the Commissioner.
- 2. Arey is in compliance with the conditions of the Suspension Order issued on March 21, 2016 and has filed the required application of reinstatement. An order of reinstatement should be issued pursuant to 191 IAC 10.10.

#### IV. ORDERS

#### IT IS THEREFORE ORDERED that:

A. The Suspension Order issued on March 21, 2016 is hereby vacated and the Iowa resident insurance producer license of Arey is reinstated; and

B. Arey shall immediately be permitted to transact and participate in the business of insurance in Iowa.

IT IS FURTHER ORDERED that, pursuant to Iowa Code § 505.8(10), the one hundred dollar (\$100) payment made with the application for reinstatement shall be paid to the Iowa Insurance Division settlement fund established for recovery of expenses and costs related to investigations and other proceedings.

This matter comes before the Iowa Insurance Commissioner pursuant to Iowa Code § 252J.9 and IAC 191–10.21(3).

# I. PARTIES AND JURISDICTION

- The Commissioner of Insurance, Nick Gerhart, directly and through his designees, administers and enforces the provisions of Iowa Code § 505.8 and the Iowa Licensing of Insurance Producers Act, Chapter 522B.
- Chad C. Arey ("Arey") is an individual with a last known mailing address of 1521
   E. 22nd St., Des Moines, IA 50317 and a national producer number of 7897628.

## II. PROCEDURAL BACKGROUND

- 3. On January 19, 2016, the Iowa Insurance Division ("Division") issued an order immediately suspending Arey's insurance producer license for noncompliance with the Iowa Department of Human Services.
- 4. On January 7, 2016 Arey filed an application in district court for judicial review of the decision of the Child Support Recovery Unit, pursuant to Iowa Code § 252J.9.
- The Division received notice of the application for judicial review on January 22,
   2016.

- 6. On January 22, 2016, the Division issued an order vacating the order for suspension, and reinstating Arey's insurance producer license.
- 7. On March 10, 2016, the Iowa District Court of Polk County issued an order denying the petition for review. *Chad Arey v. Iowa Dept. of Human Services*, Case No. CVCV051095 (*slip opinion*).

#### III. FINDINGS OF FACT

- 8. Arey is licensed as a resident insurance producer in the State of Iowa.
- 9. Arey is an individual with the birth month and date of February 24.
- Arey submitted an application for individual insurance producer license on
   October 6, 2003 in which the Commissioner was designated as agent for service of process.
- 11. On December 11, 2015 the Division notified Arey that it had received a

  Certificate of Noncompliance ("Certificate") from the Iowa Department of Human Services

  ("DHS") and that his individual insurance producer license would be suspended in 30 days if the

  DHS did not withdraw the Certificate.
  - 12. The 30 day notice period expired and the DHS did not withdraw the Certificate.

## IV. CONCLUSIONS OF LAW

- 13. Under Iowa Code section 252J.8 and Iowa Administrative Code, rule 191-10.21, the Commissioner was required to issue a notice to Respondent advising that the Certificate of Noncompliance was received and that Respondent's Iowa insurance producer license would be suspended in 30 days unless the DHS withdrew the Certificate of Noncompliance within those 30 days. This requirement has been met as the Iowa Insurance Division notified the Respondent of the intended suspension on December 11, 2015, the thirty-day notice period has now passed and the DHS has not withdrawn the Certificate of Noncompliance.
  - 14. The Division's action to suspend Arey's license was stayed pending judicial

review of the Child Support Recovery Unit decision pursuant to Iowa Code § 252J.9(3). The Iowa District Court of Polk County issued an order denying the petition for review. *Chad Arey v. Iowa Dept. of Human Services*, Case No. CVCV051095 (*slip opinion*).

15. The Commissioner has authority to order the suspension of the insurance producer license of Respondent pursuant to Iowa Code section 252J.8 and Iowa Administrative Code, rule 191-10.21.

## **ORDERS**

## IT IS THEREFORE ORDERED that:

The Iowa insurance producer license of Chad C. Arey is suspended as of the date of this Order.

- 7. The Division received notice of the application for judicial review on January 22, 2016.

## III. CONCLUSIONS OF LAW

9. Arey's filing of an application for judicial review of the decision of the Child Support Recovery Unit shall immediately stay the action of the Division to suspend Arey's license pursuant to Iowa Code § 252J.9(3).

#### IV. ORDERS

## IT IS THEREFORE ORDERED that:

- A. The Suspension Order issued on January 19, 2016 is hereby vacated and the Iowa resident insurance producer license of Arey is reinstated; and
- B. Arey shall immediately be permitted to transact and participate in the business of insurance in Iowa.
