The Iowa Insurance Division (Division) has alleged that Devin T. Degeeter (Degeeter) has engaged in activities that are in violation of Iowa Code Chapter 507B and Iowa Administrative Code 191-Chapter 16. In particular, the Division has alleged that Degeeter failed to file the required replacement form in an insurance transaction. To resolve the Division's allegations, Degeeter hereby consents to the entry of this Order and Consent to Order.


ORDER

THEREFORE, IT IS ORDERED:

1. Degeeter agrees to cease and desist from any violations of Iowa's replacement laws.
2. Degeeter shall pay a civil penalty of \$500 to the Division upon the signing of this Order. In addition, Degeeter shall pay the administrative costs of the action totaling \$250. A check for these amounts should be made payable to the Iowa Insurance Division and remitted to the Iowa Insurance Division, 330 Maple Street, Des Moines, IA 50309 with attention to John Leonhart.


