ORDER AND CONSENT TO ORDER

The Iowa Insurance Division (Division) has alleged that Ronald W. Coleman (Coleman) has engaged in activities that are in violation of Iowa Code Chapter 522. In particular, the Division has alleged that Coleman has pled guilty to and been charged with criminal offenses that have an adverse impact on his having the requisite character to maintain an insurance producer's license as set out in Iowa Code section 522B.5(1)(e). To resolve the Division's allegations, Coleman hereby consents to the entry of this Order and Consent to Order.

ORDER

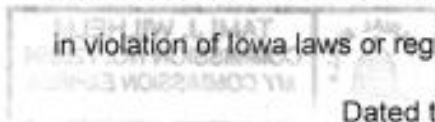
THEREFORE, IT IS ORDERED:

1. Coleman agrees to cease and desist from engaging in any criminal acts.
2. Coleman agrees to a two-year period of probation. If Coleman is found to have been convicted of any criminal charge involving an offense constituting a serious misdemeanor or greater that occurred during the probationary period, Coleman further agrees that his producer's license will be automatically suspended. Coleman will be entitled to request an administrative hearing after his license suspension if he wishes to attempt to get the suspension lifted.
3. Nothing contained in this Order shall in any way limit the right of the Division to institute administrative or legal action against Coleman for any other past conduct or future activity in violation of Iowa laws or regulations.


