The Iowa Insurance Division (Division) alleges that Leland Rainey (Rainey) sold bail bonds for the time period of February 1, 2009 to June 11, 2009 during which Rainey was unlicensed as an insurance producer in violation of Iowa Code section 522B.2. Rainey renewed his license effective June 12, 2009 and is currently a licensed insurance producer. Rainey admits the allegations contained herein, and hereby consents to the entry of this Order and Consent to Order.

ORDER

THEREFORE, IT IS ORDERED:

1. Rainey shall cease and desist violating Iowa Code section 522B.2 and its rules for the acts described above or any other insurance statutes or rules in the state of Iowa.
2. Rainey shall pay a civil penalty of \$1000.00 to the Division upon the signing of this Order. A check totaling \$1000.00 made payable to the Iowa Insurance Division should be remitted to the Iowa Insurance Division, 330 Maple Street, Des Moines, Iowa 50319 with attention to Michelle Engler, Attorney.
3. Nothing contained in the Order shall in any way limit the right of the Division to institute administrative or legal action against Rainey for any other past conduct or future activity in violation of Iowa laws or regulations.


