The Iowa Insurance Division (Division) has alleged that Ryan S. Feeck (Feeck) has engaged in activities that are in violation of Iowa Code Chapters 507B, 522 and Iowa Administrative Code 191-Chapter 15. In particular, the Division has alleged that Feeck made false statements on an application for an insurance policy for the purpose of obtaining a commission and failed to get the requisite appointment necessary to act as an agent of an insurer. To resolve the Division's allegations, Feeck hereby consents to the entry of this Order and Consent to Order.



ORDER

THEREFORE, IT IS ORDERED:

1. Feeck agrees to cease and desist from soliciting insurance for a company that he does not have the appropriate appointment with through the Division.
2. Feeck agrees to a one-year period of probation. If Feeck is found to have committed any violation of Iowa insurance law during this period of probation, he will have any sanction for such violation enhanced by the terms of this Order. Feeck further agrees to file quarterly reports with the Division during this period of probation that contain information regarding any consumer or company complaints he has received.
3. Feeck agrees to cooperate with any investigation conducted by the Division and to testify against any individual or entity as requested by the Division at an administrative hearing.
4. Feeck shall pay a civil penalty of \$1000 to the Division upon the signing of this Order. In addition, Feeck shall pay the administrative costs of the action totaling \$500. Two checks for these amounts should be made payable to the Iowa Insurance Division and remitted to the Iowa

Insurance Division, 330 Maple Street, Des Moines, IA 50309 with attention to John Leonhart.

5. Nothing contained in this Order shall in any way limit the right of the Division to institute administrative or legal action against Feeck for any other past conduct or future activity in violation of Iowa laws or regulations.
