This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Human Services ("DHS"). Under Iowa Code section 272J.9 (2009) and Iowa Administrative Code, rule 191-10.20, the Iowa Insurance Commissioner was required to issue a notice to Michael J. Blake ("Respondent") advising Respondent that the Certificate of Noncompliance was received and that Respondent's Iowa insurance producer license would be suspended in 30 days unless DHS withdrew the Certificate of Noncompliance within those 30 days. The Iowa Insurance Division's letter notifying Respondent of the intended suspension was sent on December 22, 2009. Therefore, the thirtyday notice period has now passed.

The Iowa Insurance Commissioner has authority to order the suspension of the insurance producer license of Respondent pursuant to Iowa Code section 252J.8 (2009) and Iowa Administrative Code, rule 191-10.20.

THEREFORE, IT IS ORDERED:

The Iowa insurance producer license of Michael J. Blake is suspended as of the date of this Order.

Pursuant to Iowa Code chapter 17A and IAC 191-10.10, this matter comes before the Commissioner of Insurance upon an application by Michael Blake for the reinstatement of his Iowa insurance producer's license.

## PARTIES AND JURISDICTION

- The Commissioner of Insurance, Susan E. Voss, administers and enforces the Iowa Licensing of Insurance Producers Act, Chapter 522B, pursuant to Iowa Code § 505.8 (2009).
- Michael Blake ("Blake") is an individual with a last known mailing address of 1317 Esther Street, Iowa City, IA 52240.
- Blake has filed an application with the Iowa Insurance Division ("Division")
   for reinstatement of his suspended license and the Division is authorized to issue this
   Order pursuant to Iowa Administrative Code rule 191-10.10.

### FINDINGS OF FACT

- Blake is licensed as a resident insurance producer in the State of Iowa.
- Only February 19, 2010, a suspension order was issued by the Division that stated that Blake's "insurance producer's license was suspended effective the date of the order."

- 6. The Division's letter notifying Blake of such intended suspension was sent on December 22, 2009. Based on the language of the required notice of intended suspension Blake was advised that the Iowa Department of Human Services ("DHS") had to withdraw the Certificate of Noncompliance, prior to Blake's license becoming reinstated by the Division.
  - DHS withdrew the Certificate of Noncompliance on July 7, 2010.
- Blake's suspension provided for in the suspension order has been served as Blake has met the requirements of DHS.
- On January 27, 2011, Blake filed an application for reinstatement after suspension of his insurance producer license as required by IAC 191-10.10.
- 10. As Blake has complied with the suspension and filed the necessary reinstatement application, an order of reinstatement of his lowa insurance producer's license will be issued.

### CONCLUSIONS OF LAW

11. Blake is in compliance with the terms of his suspension found in the suspension order issued by the Division dated February 19, 2010 and has filed the required application of reinstatement so an order of reinstatement should be issued pursuant to IAC 191-10.10.

# THEREFORE, IT IS ORDERED THAT:

The lowa resident insurance producer license of Blake is no longer suspended;

Blake shall immediately be able to transact and participate in the business of insurance in lowa.
