- 2. Simon shall pay a civil penalty of \$150.00 and a \$500.00 penalty for violation of lowa Code 523A.204, failure to submit an Annual Report. Within 30 days of the date of the signing of this Order, a check totaling \$650.00 made payable to the lowa Insurance Division shall be remitted to the Iowa Insurance Division, 330 Maple Street, Des Moines, Iowa 50319 with attention to Michelle Engler, Attorney.

 Nothing contained in this Order shall in any way limit the right of the Division to institute administrative or legal action against Simon for any other past conduct or future activity in violation of lowa laws or regulations.
