STIPULATION OF FACT

- Respondent is required to maintain a surplus in cash or invested in securities authorized by law of not less than \$2,500,000. See Iowa Code section 515.69(1) (2011).
- 2. Respondent's current surplus is less than the \$2,500,000 required by Iowa Code section 515.69(1) (2011).

3. Respondent is currently attempting to raise additional funds that will satisfy the \$2,500,000 surplus requirement of Iowa Code section 515.69(1) (2011).

ORDER

4. Until such time as Respondent's surplus meets or exceeds \$2,500,000, Respondent agrees to not write insurance business in Iowa prior to December 31, 2011. If Respondent does not raise additional funds to satisfy the \$2,500,000 surplus requirement of Iowa Code section 515.69(1) by December 31, 2011, Respondent agrees to the voluntary suspension of its Certificate of Authority and waives the right to a hearing.
