Now comes the Iowa Insurance Division ("Division"), pursuant to the provisions of the Iowa Licensing of Insurance Producers Act – chapter 522B. The Division alleges that Jeffrey G. Jones ("Jones") failed to comply with The Centers for Medicare and Medicaid Services ("CMS") and its requirement that all agents be certified prior to marketing and selling of Medicare products pursuant to Iowa Code § 522B.11(1)(b) (2011). Jones consents to the entry of this Order. Jones admits that the Iowa Insurance Division has personal jurisdiction over him and has subject matter jurisdiction over this matter.

ORDER


WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code § 522B.11 that:

1. Jones shall cease and desist violating Iowa Code chapter 522B and its rules for the acts described above or any other insurance statutes or rules in the state of Iowa.
2. Jones shall pay a civil penalty of \$350 to the Division upon the signing of this Order. A check totaling \$350 made payable to the Iowa Insurance Division should be remitted to the Iowa Insurance Division, 330 Maple Street, Des Moines, Iowa 50319 with attention to Robert Koppin, Enforcement Bureau Chief.
3. Jones shall complete, if not already done so, his current CMS certification requirement prior to doing any future solicitation or selling of Medicare products.

4. Nothing contained in the Order shall in any way limit the right of the Division to institute administrative or legal action against Jones for any other past conduct or future activity in violation of Iowa laws or regulations.
