This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Revenue ("Revenue"). Under Iowa Code section 272D.9 (2011) and Iowa Administrative Code, rule 191-10.23, the Iowa Insurance Commissioner was required to issue a notice to Charles Sessions ("Respondent") advising Respondent that the Certificate of Noncompliance was received and that Respondent's Iowa insurance producer license would be suspended in 60 days unless Revenue withdrew the Certificate of Noncompliance within those 60 days. The Iowa Insurance Division's letter notifying Respondent of the intended suspension was sent on November 15, 2011. Therefore, the sixty-day notice period has now passed.

The Iowa Insurance Commissioner has authority to order the suspension of the insurance producer license of Respondent pursuant to Iowa Code section 252J.9 (2011) and Iowa Administrative Code, rule 191-10.23.

THEREFORE, IT IS ORDERED:

The Iowa insurance producer license of **Charles Sessions** is suspended as of the date of this Order.

**ORDER REINSTATING LICENSE
AFTER SUSPENSION**

Division Docket No.: 73409

Pursuant to Iowa Code chapter 17A and IAC 191-10.10, this matter comes before the Commissioner of Insurance upon an application by Charles Sessions for the reinstatement of his Iowa insurance producer's license.

PARTIES AND JURISDICTION

1. The Commissioner of Insurance, Susan E. Voss, administers and enforces the Iowa Licensing of Insurance Producers Act, Chapter 522B, pursuant to Iowa Code § 505.8 (2011).

2. Charles Sessions ("Sessions") is an individual with a last known mailing address of 602 Southview Drive; Osceola, IA 50213.

3. Sessions has filed an application with the Iowa Insurance Division ("Division") for reinstatement of his suspended license and the Division is authorized to issue this Order pursuant to Iowa Administrative Code rule 191-10.10.

FINDINGS OF FACT

4. Sessions is licensed as a resident insurance producer in the State of Iowa.

5. Only February 21, 2012, a suspension order was issued by the Division that stated that Sessions' "insurance producer's license was suspended effective the date of the order."

6. The Division's letter notifying Sessions of such intended suspension was sent on November 15, 2011. Based on the language of the required notice of intended suspension Sessions was advised that the Iowa Department of Revenue ("Revenue") had to withdraw the Certificate of Noncompliance, prior to Sessions' license becoming reinstated by the Division.

7. Revenue withdrew the Certificate of Noncompliance on April 6, 2012.

8. Sessions' suspension provided for in the suspension order has been served as Sessions has met the requirements of Revenue.

9. On April 9, 2012, Sessions filed an application for reinstatement after suspension of his insurance producer license as required by IAC 191-10.10.

10. As Sessions has complied with the suspension and filed the necessary reinstatement application, an order of reinstatement of his Iowa insurance producer's license will be issued.

CONCLUSIONS OF LAW


11. Sessions is in compliance with the terms of his suspension found in the suspension order issued by the Division dated February 21, 2012 and has filed the required application of reinstatement so an order of reinstatement should be issued pursuant to IAC 191-10.10.

THEREFORE, IT IS ORDERED THAT:

1. The Iowa resident insurance producer license of Sessions is no longer suspended;

2. Sessions shall immediately be able to transact and participate in the business of insurance in Iowa.
