**ORDER FOR SUSPENSION**


This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Revenue ("Revenue"). Under Iowa Code section 272D.9 (2011) and Iowa Administrative Code, rule 191-10.23, the Iowa Insurance Commissioner was required to issue a notice to **Ann Marie Burns** ("Respondent") advising Respondent that the Certificate of Noncompliance was received and that Respondent's Iowa insurance producer license would be suspended in 60 days unless Revenue withdrew the Certificate of Noncompliance within those 60 days. The Iowa Insurance Division's letter notifying Respondent of the intended suspension was sent on January 27, 2012. Therefore, the sixty-day notice period has now passed.

The Iowa Insurance Commissioner has authority to order the suspension of the insurance producer license of Respondent pursuant to Iowa Code section 252J.9 (2011) and Iowa Administrative Code, rule 191-10.23.

THEREFORE, IT IS ORDERED:

The Iowa insurance producer license of **Ann Marie Burns** is suspended as of the date of this Order.

**ORDER REINSTATING LICENSE  
AFTER SUSPENSION**

Division Docket No.: 74153

Pursuant to Iowa Code chapter 17A and IAC 191-10.10, this matter comes before the Commissioner of Insurance upon an application by Ann Marie Burns for the reinstatement of her Iowa insurance producer's license.

**PARTIES AND JURISDICTION**

1. The Commissioner of Insurance, Susan E. Voss, administers and enforces the Iowa Licensing of Insurance Producers Act, Chapter 522B, pursuant to Iowa Code § 505.8 (2011).

2. Ann Marie Burns ("Burns") is an individual with a last known mailing address of 6201 Windhaven Pkwy #1913 Plano, TX 75093.

3. Burns has filed an application with the Iowa Insurance Division ("Division") for reinstatement of her suspended license and the Division is authorized to issue this Order pursuant to Iowa Administrative Code rule 191-10.10.

**FINDINGS OF FACT**

4. Burns is licensed as a non-resident insurance producer in the State of Iowa.

5. Only April 5, 2012, a suspension order was issued by the Division that stated that Burns' "insurance producer's license was suspended effective the date of the order."

6. The Division's letter notifying Burns of such intended suspension was sent on January 27, 2012. Based on the language of the required notice of intended suspension Burns was advised that the Iowa Department of Revenue ("Revenue") had to withdraw the Certificate of Noncompliance, prior to Burns' license becoming reinstated by the Division.

7. Revenue withdrew the Certificate of Noncompliance on May 23, 2012.

8. Burns' suspension provided for in the suspension order has been served as Burns has met the requirements of Revenue.

9. On May 24, 2012, Burns filed an application for reinstatement after suspension of her insurance producer license as required by IAC 191-10.10.

10. As Burns has complied with the suspension and filed the necessary reinstatement application, an order of reinstatement of her Iowa insurance producer's license will be issued.

#### **CONCLUSIONS OF LAW**

11. Burns is in compliance with the terms of her suspension found in the suspension order issued by the Division dated April 5, 2012 and has filed the required application of reinstatement so an order of reinstatement should be issued pursuant to IAC 191-10.10.

THEREFORE, IT IS ORDERED THAT:

1. The Iowa resident insurance producer license of Burns is no longer suspended;

2. Burns shall immediately be able to transact and participate in the business of insurance in Iowa.
