- B. Stalheim's Iowa insurance producer license shall be placed on probationary status to resolve the pending charges in this matter. The period of probation is effective immediately upon the execution of this order and shall remain in place until the following requirements are met:
- 1) Stalheim shall pay a civil penalty of \$1000 to the Division. A check made payable to the Iowa Insurance Division should be remitted to the Iowa Insurance Division, 330 Maple Street, Des Moines, IA 50319.

2) Stalheim shall complete six hours of continuing education in the area of

ethics. No more than three hours may be from self study courses and all courses must be listed

on the Iowa Insurance Division website as approved courses for producer continuing education.

These course credits may not be applied toward license renewal requirements pursuant to 191

IAC 11.3. Stalheim is responsible for all costs associated with the continuing education.

Stalheim shall submit documentation verifying course completion to the Iowa Insurance

Division, 330 Maple Street, Des Moines, IA 50319.

3) Upon receipt of the civil penalty and verification of the above described

continuing education by the Iowa Insurance Division, Stalheim's probation shall be terminated.

3. Other understandings. Stalheim acknowledges the following:

a. Nothing contained in this Order and Consent to Order shall be construed to

deprive any person or entity of any private right of action.

b. Nothing contained in this Order shall in any way limit the right of the Division to

institute administrative or legal action against Stalheim for any other past conduct or future activity

in violation of Iowa laws or regulations.

Stalheim shall submit documentation verifying course completion to the Iowa Insurance Division, 330 Maple Street, Des Moines, IA 50319.
- c.) Upon receipt of the civil penalty and the above described continuing education verification by the Iowa Insurance Division, Stalheim's probation shall be terminated.
- 3. Nothing contained in this Order and Consent to Order shall be construed to deprive any person or entity of any private right of action.

Nothing contained in this Order shall in any way limit the right of the Division to institute 4. administrative or legal action against Stalheim for any other past conduct or future activity in violation of Iowa laws or regulations.
