Now comes the Iowa Insurance Division ("Division"), pursuant to the provisions of the Iowa Cemetery and Funeral Merchandise and Funeral Services Act – chapter 523A. The Division alleges that John M. Stepanek ("Stepanek") failed to file an annual report by a preneed seller in violation of Iowa Code § 523A.502A. Stepanek consents to the entry of this Order. Stepanek admits that the Iowa Insurance Division has personal jurisdiction over him and has subject matter jurisdiction over this matter.

ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code §§ 523A.501 et al., 523A.801, and 523A.805 that:

- 1. Stepanek shall provide the Division with the information necessary to comply with Iowa Code § 523A.502A within two weeks of the signing of this order.
- 2. Stepanek shall cease and desist violating lowa Code chapter 523A and its rules for the acts described above or any other statutes or rules pursuant to chapter 523A.
- 3. Stepanek shall not be required to pay a civil penalty to the Division upon the signing of this Order.
- 5. Nothing contained in the Order shall in any way limit the right of the Division to institute administrative or legal action against Stepanek for any other past conduct or future activity in violation of Iowa laws or regulations.
