Now comes the Iowa Insurance Division ("Division"), pursuant to the provisions of the Iowa Cemetery and Funeral Merchandise and Funeral Services Act — chapter 523A. The Division alleges that Casey C. Henry ("Henry") failed to cancel a preneed seller's license in violation of Iowa Code § 523A.501(5), failed to notify the Division of changes to his licensing information in violation of Iowa Code § 523A.502(7), and failed to file an annual report by a preneed seller in violation of Iowa Code § 523A.502A. Henry consents to the entry of this Order. Henry admits that the Iowa Insurance Division has personal jurisdiction over him and has subject matter jurisdiction over this matter.

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code §§ 523A.801, 523A.501 et al. and 523A.805 that:

- 1. Henry shall provide the Division with the information necessary to comply with Iowa Code §§ 523A.501, 523A.502 and 523A.502A within two weeks of the signing of this order.
- 2. Henry shall cease and desist violating Iowa Code chapter 523A and its rules for the acts described above or any other statutes or rules pursuant to chapter 523A.
- 3. Henry shall voluntarily surrender his preneed sales agent license upon the signing of this order.
- 4. Henry shall pay a civil penalty of \$150 to the Division. A check for \$50 made payable to the Iowa Insurance Division should be remitted to the Iowa Insurance Division, 330 Maple Street, Des Moines, Iowa 50319 with attention to Robert Koppin, Enforcement Bureau Chief,

upon the signing of the Order. The remaining \$100 shall be paid in two equal monthly installments of \$50 due on October 19, 2012 and November 19, 2012 sent to the Division as described above.

5. Nothing contained in the Order shall in any way limit the right of the Division to institute administrative or legal action against Henry for any other past conduct or future activity in violation of Iowa laws or regulations.
