Now comes the Iowa Insurance Division ("Division"), pursuant to the provisions of the Iowa Cemetery and Funeral Merchandise and Funeral Services Act – Iowa Code chapter 523A. The Division alleges that Marilyn A. Reid, the owner of Reid's Funeral Chapel, and Reid's Funeral Chapel failed to submit a renewal application for a Preneed Seller license for Reid's Funeral Chapel after notification of the expiration of the license in violation of Iowa Code § 523A.501(1) (2011) and IAC 191-103.1, 105.6(17), 105.7(1)(a) and 105.7(2). The Division alleges that Fred Retz failed to cease selling preneed products / services for Reid's Funeral Chapel after it's license expiration date and after notification of the expiration of the license in violation of Iowa Code § 523A.502(1) (2011) and IAC 191-103.1, 105.7(1)(B), and 105.7(2). Reid's Funeral Chapel and Marilyn A. Reid consent to the entry of this Order. Fred Retz, without admitting to or denying the allegations, consents to the entry of this Order. Reid's Funeral Chapel, Marilyn A. Reid and Fred Retz admit that the Iowa Insurance Division has personal jurisdiction over them and has subject matter jurisdiction over this matter.

AGREEMENT AND UNDERTAKINGS

Reid's Funeral Chapel and Marilyn A. Reid agree to and represent that purchasers of preneed products or services would be entitled to rescind sales made during the time period that Reid's Funeral Chapel and Marilyn A. Reid were not properly licensed, if desired by the purchaser, and receive a full credit or refund.

ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code §§ 523A.801, 523A.501 et al. and 523A.805 that:

- 1. Reid's Funeral Chapel, Marilyn A. Reid, and Fred Retz shall provide the Division with the information necessary to comply with Iowa Code §§ 523A.501, 523A.502 and 523A.502A within two weeks of the date of the signing of this order.
- 2. Reid's Funeral Chapel, Marilyn A. Reid, and Fred Retz shall cease and desist violating lowa Code chapter 523A and its rules for the acts described above or any other statutes or rules pursuant to chapter 523A.
- Reid's Funeral Chapel and Marilyn A. Reid shall comply with the requirements stated in Agreement and Undertaking section of the Order.
- 4. Reid's Funeral Chapel, Marilyn A. Reid, and Fred Retz shall pay a civil penalty of \$250 to the Division. The check for \$250 should be made payable to the Iowa Insurance Division and mailed with the Order and Consent to Order addressed to the Iowa Insurance Division, 330 Maple Street, Des Moines, Iowa 50319 with attention to Robert Koppin, Enforcement Bureau Chief, upon the signing of the Order.
- 5. Nothing contained in the Order shall in any way limit the right of the Division to institute administrative or legal action against Reid's Funeral Chapel, Marilyn A. Reid, and Fred Retz for any other past conduct or future activity in violation of Iowa laws or regulations.
