Now comes the Iowa Insurance Division ("Division"), pursuant to the provisions of the Iowa Licensing of Insurance Producers Act — chapter 522B. The Division alleges that Joseph R. Flaherty ("Flaherty") has committed an unfair insurance trade practice when exchanging annuity policies pursuant to Iowa Code §§ 522B.11(1)(g) (2013) and 507B.4(3)(a) (2013). Flaherty consents to the entry of this Order. Flaherty admits that the Iowa Insurance Division has personal jurisdiction over him and has subject matter jurisdiction over this matter.

AGREEMENT AND UNDERTAKING

Flaherty agrees to and represents that he improperly solicited and executed an exchange of annuity contracts for an elderly client. Flaherty agrees that this transaction resulted in a net loss to the lowa couple of \$1,397.71. Flaherty also agrees to resolve this administrative matter by paying a sum totaling \$1,397.71 by check in equal monthly installments of \$150.00 plus a final installment of \$47.71. The first installment of \$150.00 is due upon the signing of this order.

ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code § 522B.11 that:

- 1. Flaherty shall cease and desist violating Iowa Code chapter 522B and its rules for the acts described above or any other insurance statutes or rules in the state of Iowa.
- 2. Flaherty shall make monthly installment payment of \$150.00 per month with a final installment payment of \$47.71 with the check being payable to the lowa couple until the sum of

monthly repayments equals \$1,397.71. The first monthly installment of \$150.00 is due to the Division upon the signing of this Order. Each check should be remitted to the Iowa Insurance Division at 330 Maple Street, Des Moines, Iowa 50319 (after June 21, 2013 the new mailing address will be Two Ruan Center, 601 Locust, 4th Floor, Des Moines, Iowa 50309-3738) with attention to Robert Koppin, Enforcement Bureau Chief. The envelope containing the check should be marked "Personal and Confidential." The Division will forward the check to the Iowa couple for deposit into their bank account.

3. Nothing contained in the Order shall in any way limit the right of the Division to institute administrative or legal action against Flaherty for any other past conduct or future activity in violation of lowa laws or regulations.
