Now comes the Iowa Insurance Division, represented by the Assistant Commissioner of Insurance, Rosanne Mead, pursuant to the provisions of the Iowa Licensing of Insurance Producers Act, Iowa Code chapter 522B, regarding Joyce B. Thomas' failure to timely report an administrative action taken by another state insurance agency. Joyce B. Thomas admits to the violations contained in this Order and consents to the entry of this Order. Joyce B. Thomas admits that the Iowa Insurance Division has personal jurisdiction over her and has subject matter jurisdiction over this matter.

FINDINGS OF FACT

1. Joyce B. Thomas ("Respondent") is an individual who has a last known home mailing address of 1760 North Nellis Boulevard, Las Vegas, NV 89115.
2. Respondent became licensed as an insurance producer in the state of Iowa on January 14, 2000. Respondent's insurance producer number is 219965.
3. On May 24, 2005, Respondent entered into a Consent Order with the Georgia Office of Commissioner of Insurance whereby she was issued a license on a probationary status because of the administrative actions taken against her previously by the Nevada Division of Insurance.
4. Respondent did not notify the Division of this administrative action within thirty days as required by Iowa Code section 522B.16 and Iowa Administrative Rule 191-10.20(4).

ORDERS

WHEREFORE, IT IS HEREBY ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code section 505.8 (2005) as follows:

- A. Respondent shall Cease and Desist violating Iowa Code chapter 522B and its rules for the acts described above or any other insurance statutes or rules in the State of Iowa.
- B. Respondent shall pay a civil penalty of \$125 and \$125 in costs to the Division upon her signing of this Consent Order. A check totaling \$250 should be remitted to the Iowa Insurance Division, 330 Maple Street, Des Moines, Iowa 50319 with attention to Bob Koppin, Enforcement Attorney.

CONSENT TO ORDER

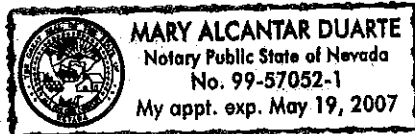


