Now comes the Iowa Insurance Division ("Division"), pursuant to the provisions of the Iowa Cemetery and Funeral Merchandise and Funeral Services Act – chapter 523A. The Division alleges that Angela L. Crawford ("Crawford") failed to notify the Division of changes to her licensing information in violation of Iowa Code § 523A.502(7), and failed to file an annual report by a preneed seller in violation of Iowa Code § 523A.502A. Crawford consents to the entry of this Order. Crawford admits that the Iowa Insurance Division has personal jurisdiction over her and has subject matter jurisdiction over this matter.

ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code §§ 523A.801, 523A.501 et al. and 523A.805 that:

- 1. Crawford shall provide the Division with the information necessary to comply with Iowa Code §§ 523A.501, 523A.502 and 523A.502A within two weeks of the signing of this order.
- 2. Crawford shall cease and desist violating Iowa Code chapter 523A and its rules for the acts described above or any other statutes or rules pursuant to chapter 523A.
- Crawford's preneed sales agent license shall be revoked upon the signing of this order.
- 4. Crawford shall pay a civil penalty of \$500 only if she reapplies for any license with the Division. The \$500 civil penalty would be due and payable upon the application for any license with the Division.

5. Nothing contained in the Order shall in any way limit the right of the Division to institute administrative or legal action against Crawford for any other past conduct or future activity in violation of Iowa laws or regulations.
