ORDER AND CONSENT TO ORDER

DIVISION DOCKET NO. 81327

The Iowa Insurance Division (Division) has alleged that Lindsay Gilliatt (Gilliatt) has engaged in activities that are in violation of Iowa Code Chapters 507B and 522B. In particular, the Division has alleged that Gilliatt has improperly withheld, misappropriated or converted moneys in the course of doing insurance business; used dishonest practices or demonstrated untrustworthiness or financial irresponsibility in the conduct of business and failed to promptly respond to a Division inquiry. To resolve the matter, the Division and Gilliatt enter into the following Order and Consent to Order.

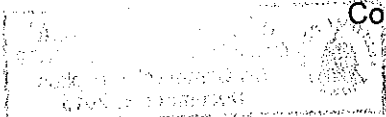
ORDER AND CONSENT TO ORDER

THEREFORE, IT IS ORDERED:

1. Gilliatt consents to the revocation of her insurance producer license in the state of Iowa. The revocation of Gilliatt's Iowa insurance producer license shall be effective immediately upon the signing of the Consent to Order.
2. Gilliatt acknowledges the following:
 - a. Nothing contained in this Order shall be construed to deprive any person or entity of any private right of action under any law.
 - b. Nothing contained in this Order shall be construed to limit the authority of the Division to enforce laws, regulations or rules against Gilliatt.
