Pursuant to Iowa Code chapter 17A and IAC 191-10.10, this matter comes before the Commissioner of Insurance upon an application by Mark Schroder for the reinstatement of his Iowa insurance producer's license.

PARTIES AND JURISDICTION

1. The Commissioner of Insurance, Nick Gerhart, administers and enforces the Iowa Licensing of Insurance Producers Act, Chapter 522B, pursuant to Iowa Code § 505.8 (2013).

2. Mark Schroder ("Schroder") is an individual with a last known mailing address of 8518 Prairie Ridge Drive, Johnston, IA 50131.

3. Schroder has filed an application with the Iowa Insurance Division ("Division") for reinstatement of his suspended license and the Division is authorized to issue this Order pursuant to Iowa Administrative Code rule 191-10.10.

FINDINGS OF FACT

4. Schroder is licensed as a resident insurance producer in the State of Iowa.

5. On August 28, 2013, a suspension order was issued by the Division that stated that Schroder's "insurance producer's license was suspended effective the date of the order."

6. The Division's letter notifying Schroder of such intended suspension was sent on June 27, 2013. Based on the language of the required notice of intended suspension Schroder was advised that the Iowa Department of Revenue ("Revenue") had to withdraw the Certificate of Noncompliance, prior to Schroder's license becoming reinstated by the Division.

7. Revenue withdrew the Certificate of Noncompliance on November 8, 2013.

8. Schroder's suspension provided for in the suspension order has been served as Schroder has met the requirements of Revenue.

9. On November 12, 2013, Schroder filed an application for reinstatement after suspension of his insurance producer license as required by IAC 191-10.10.

10. As Schroder has complied with the suspension and filed the necessary reinstatement application, an order of reinstatement of his Iowa insurance producer's license will be issued.

CONCLUSIONS OF LAW


11. Schroder is in compliance with the terms of his suspension found in the suspension order issued by the Division dated August 28, 2013 and has filed the required application of reinstatement so an order of reinstatement should be issued pursuant to IAC 191-10.10.

THEREFORE, IT IS ORDERED THAT:

1. The Iowa resident insurance producer license of Schroder is no longer suspended;

2. Schroder shall immediately be able to transact and participate in the business of insurance in Iowa.



This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Revenue ("Revenue"). Under Iowa Code section 272D.9 (2013) and Iowa Administrative Code, rule 191-10.23, the Iowa Insurance Commissioner was required to issue a notice to Mark Schroder ("Respondent") advising Respondent that the Certificate of Noncompliance was received and that Respondent's Iowa insurance producer license would be suspended in 60 days unless Revenue withdrew the Certificate of Noncompliance within those 60 days. The Iowa Insurance Division's letter notifying Respondent of the intended suspension was sent on June 27, 2013. Therefore, the sixty-day notice period has now passed.

The Iowa Insurance Commissioner has authority to order the suspension of the insurance producer license of Respondent pursuant to Iowa Code section 252J.9 (2013) and Iowa Administrative Code, rule 191-10.23.

THEREFORE, IT IS ORDERED:

The Iowa insurance producer license of **Mark Schroder** is suspended as of the date of this Order.
