Now comes the lowa Insurance Division ("Division") pursuant to the provisions of the Iowa Licensing of Insurance Producers Act – Iowa Code Chapter 522B. The Division alleges that Michael Lamar Jones ("Jones") provided incorrect information in an insurance license application and failed to report within 30 days of the initial pretrial hearing date a criminal prosecution in violation of Iowa Code §§ 522B.11(1)(a) and 522B.16 (2013). Jones consents to the entry of this Order. Jones admits that the Iowa Insurance Division has personal jurisdiction over him and has subject matter jurisdiction over this matter.

## ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code Chapter 522 that:

1. Jones shall cease and desist violating Iowa Code chapter 522B and its rules.

2. Jones shall pay a civil penalty of \$400 and costs of \$100 to the Division due upon the signing of this Order. The check for \$500 shall be made payable to the lowa Insurance Division and mailed to the lowa Insurance Division, 601 Locust St., 4<sup>th</sup> Floor, Des Moines, Iowa 50309 with attention to Robert Koppin, Enforcement Bureau Chief.

3. Nothing contained in this Order shall in any way limit the right of the Division to institute administrative or legal action against Jones for any other past conduct or future activity in violation of lowa laws or regulations.
