Now comes the Iowa Insurance Division (Division) represented by Enforcement Bureau Attorney John Leonhart and alleges that Dallas Buck III ("Buck") has violated the provisions of Iowa Code Chapter 522B-the Licensing of Insurance Producers Act. Buck consents to the entry of the Order. Buck admits that the Division has personal jurisdiction over him and has subject matter jurisdiction over this matter.

PARTIES AND JURISDCITION

1. The Commissioner of Insurance, Nick Gerhart, enforces Iowa Code Chapter 522B-the Licensing of Insurance Producers Act.
2. Buck is an individual with a last known mailing address of 1165 Jonquil Lane, Boone, IA 50036.
3. Buck is a licensed insurance producer in the state of Iowa.

FACTUAL BACKGROUND


4. Buck received a Consent to Work in the Business of Insurance (the "Consent") from the Division on October 11, 2010.
5. The Consent stated that if Buck changed employers he had an affirmative duty to notify the Division of the change.
6. The Division contacted Buck regarding his employment status and he informed the Division that he had changed employers but failed to notify the Division of the change as required by his Consent.
7. Buck's failure to notify the Division of his change in employment status is in violation of Iowa Code section 522B.11(1)(b).

ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commission of Insurance by Iowa Code Chapter 522B that:

8. Buck shall cease and desist from violating Iowa Code Chapter 522B
9. Buck shall pay a civil penalty of \$100. A check in the amount of \$100 payable to the Iowa Insurance Division is due upon the signing of this Order. The check and the signed Order should be sent to the Iowa Insurance Division, Two Ruan Center, 601 Locust Street, 4th Floor, Des Moines, IA 50309 with attention to John Leonhart, Enforcement Attorney.
10. Nothing contained in this Order shall be construed to limit the authority of the Division to institute administrative or legal action against Buck for any other past conduct of future activity in violation of Iowa laws and regulations.


