The Iowa Insurance Division ("Division"), pursuant to the provisions of the Iowa Licensing of Insurance Producers Act – chapter 522B has sought the entry of this Order.

## **ALLEGATIONS OF FACT**

The Division has alleged that Sarah Carry (Carry) violated Iowa Code § 522B.11(d) by improperly withholding, misappropriating and converting consumer premium received in the course of doing insurance business by altering cash receipt reports to cover up premium taken from a client in the amount of \$533.25. The Division has further alleged that Carry's misappropriation of consumer premium demonstrates incompetence, untrustworthiness or financial irresponsibility in the conduct of business in violation of Iowa Code § 522B.11(h).

## **STIPULATIONS**

- 1. **Jurisdiction.** Carry consents to the entry of this Order and admits that the lowa Insurance Division has personal jurisdiction over her and has subject matter jurisdiction over this matter.
- 2. Revocation of insurance producer license and permanent bar. Carry agrees to the revocation of her insurance producer license in the state of lowa based on the allegations. Carry also agrees to be barred from reapplying for an insurance producer license in the state of lowa based on the allegations made in this Order.

### **ORDER**

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code Chapter 522B that:

- 1. Carry's insurance producer license in the state of lowa is hereby revoked. Carry is permanently barred from reapplying for an insurance producer license in the state of lowa.
- 2. Nothing contained in this Order shall in any way limit the right of the Division to institute administrative or legal action against Carry for any other past conduct or future activity in violation of Iowa laws or regulations.
