COMES NOW the Iowa Insurance Division pursuant to the provisions of the Iowa Licensing of Insurance Producers Act — chapter 522B. The Division alleges that Jerrick demonstrated incompetence in giving insurance advice and taking action that was not in the financial best interest of an Iowa consumer in violation of Iowa Code 522B.11(1)(h) (2013). Jerrick hereby consents to the entry of this Order. Jerrick admits that the Iowa Insurance Division has personal jurisdiction over him and has subject matter jurisdiction over this matter.

AGREEMENT AND ACKNOWLEDGMENT

- 1. Cease and Desist. Jerrick agrees to cease and desist violating Iowa Code chapter 522B based on the allegation made in this Order.
- 3. Acknowledgment of payment made to lowa insureds. The Division acknowledges the payment of \$15,000 as a contribution along with a payment from his broker-dealer to make the lowa insureds whole for their loss. The Division has taken Jerrick's payment to the lowa insureds into consideration in determining the sanction and no civil penalty in this matter.

ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the

Commissioner of Insurance by Iowa Code Chapter 522B that:

A. Jerrick will cease and desist from future violations of Iowa Code Chapter

522B.

B. Nothing contained in this Order shall be construed to deprive any person

or entity of any private right of action under any law.

C. The Iowa Insurance Division reserves its right to take Administrative

Action for any violation of the lowa insurance statutes and/or regulations by Jerrick

unknown to the Division at the date of the signing of this Order and Consent to Order.
