The Iowa Insurance Division ("Division") pursuant to the provisions of the Iowa Uniform Securities Act – Iowa Code Chapter 502, the Iowa Insurance Trade Practices Act – Chapter 507B and the Iowa Licensing of Insurance Producers Act – Iowa Code Chapter 522B has sought the entry of this Order.

ALLEGATIONS OF FACT

The Division has alleged that Deanna McClean ("McClean") violated Iowa Code § 507B.4(3)(i) when she paid customers' first year premiums for insurance policies to improve her commission scale and inflate her sales commissions by a total of \$38,915 for the years 2011 and 2012. The Division further alleged that McClean violated Iowa Code § 522B.11(1)(p) by failing or refusing to cooperate in an investigation by the Commissioner. McClean's violation of Iowa Code § 507B.4(3) is also a violation of Iowa Code § 502.412(4)(e) and Iowa Code § 522B.11(1)(b) subjecting her to sanction on her securities agent and insurance producer licenses.

STIPULATIONS

1. **Jurisdiction.** McClean consents to the entry of this Order and admits that the lowa Insurance Division has personal jurisdiction over her and has subject matter jurisdiction over this matter.

- 2. Revocation of insurance producer license and permanent bar. McClean agrees to the revocation of her insurance producer license in the state of lowa based on the allegations. McClean also agrees to be barred from reapplying for an insurance producer license in the state of lowa based on the allegations made in this Order.
- 3. Revocation of securities license and permanent bar. McClean agrees to the revocation of her securities license in the state of lowa based on the allegations. McClean also agrees to be barred from reapplying for a securities license in the state of lowa based on the allegations made in this Order.

ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code Chapters 502, 507B and 522B that:

- McClean's insurance producer license in the state of lowa is hereby revoked.
 McClean is barred from reapplying for an insurance producer license from the date this
 Order is signed by the Commissioner.
- 2. McClean's securities license in the state of Iowa is hereby revoked. McClean is barred from applying for a securities agent license or investment adviser representative license from the date this Order is signed by the Commissioner.

3. Nothing contained in this Order shall in any way limit the right of the Division to institute administrative or legal action against McClean for any other past conduct or future activity in violation of lowa laws or regulations.
