Pursuant to Iowa Code chapter 17A and 191 IAC 10.10, this matter comes before the Commissioner of Insurance upon an application by Megan Kalny for the reinstatement of her Iowa insurance producer's license.

## PARTIES AND JURISDICTION

- 1. The Commissioner of Insurance, Nick Gerhart, administers and enforces the Iowa Licensing of Insurance Producers Act, Chapter 522B, pursuant to Iowa Code § 505.8 (2013).
- 2. Megan Kalny ("Kalny") is an individual with a last known mailing address of 2617 Patricia Drive #4, Urbandale, IA 50322.
- 3. Kalny has filed an application with the Iowa Insurance Division ("Division") for reinstatement of her suspended license and the Division is authorized to issue this Order pursuant to 191 IAC 10.10.

### **FINDINGS OF FACT**

- 4. Kalny is licensed as a non-resident insurance producer in the State of Iowa.
- 5. On February 8, 2013, a suspension order was issued by the Division that stated that Kalny's "insurance producer's license was suspended effective the date of the order."

- 6. The Division's letter notifying Kalny of such intended suspension was sent on October 9, 2012. Based on the language of the required notice of intended suspension Kalny was advised that the Iowa Department of Revenue ("Revenue") had to withdraw the Certificate of Noncompliance, prior to Kalny's license becoming reinstated by the Division.
  - 7. Revenue withdrew the Certificate of Noncompliance on April 23, 2014.
- 8. Kalny's suspension provided for in the suspension order has been served as Kalny has met the requirements of Revenue.
- 9. On April 28, 2014, Kalny filed an application for reinstatement after suspension of her insurance producer license as required by 191 IAC 10.10.
- 10. As Kalny has complied with the suspension and filed the necessary reinstatement application, an order of reinstatement of her lowa insurance producer's license will be issued.

#### CONCLUSIONS OF LAW

11. Kalny is in compliance with the terms of her suspension found in the suspension order issued by the Division dated February 8, 2013 and has filed the required application of reinstatement so an order of reinstatement should be issued pursuant to 191 IAC 10.10.

## THEREFORE, IT IS ORDERED THAT:

1. The lowa resident insurance producer license of Kalny is no longer suspended;

2. Kalny shall immediately be able to transact and participate in the business of insurance in lowa.

This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Revenue ("Revenue"). Under Iowa Code section 272D.9 (2011) and Iowa Administrative Code, rule 191-10.23, the Iowa Insurance Commissioner was required to issue a notice to Megan Kalny ("Respondent") advising Respondent that the Certificate of Noncompliance was received and that Respondent's Iowa insurance producer license would be suspended in 60 days unless Revenue withdrew the Certificate of Noncompliance within those 60 days. The Iowa Insurance Division's letter notifying Respondent of the intended suspension was sent on October 10, 2012 and resent November 9, 2013 because of a bad address issue. Therefore, the sixty-day notice period has now passed.

The Iowa Insurance Commissioner has authority to order the suspension of the insurance producer license of Respondent pursuant to Iowa Code section 252J.9 (2011) and Iowa Administrative Code, rule 191-10.23.

### THEREFORE, IT IS ORDERED:

The Iowa insurance producer license of Megan Kalny is suspended as of the date of this Order.
