Now comes the Iowa Insurance Division ("Division") pursuant to the provisions of the Iowa Cemetery and Funeral Merchandise and Funeral Services Act - Iowa Code Chapter 523A and Iowa Administrative Code Chapters 191-103, 105 & 106. The Division alleges that Robert L. and Michelle R. Dugger Funeral Homes, LLC (hereafter "Seller") and Robert LaMonte Dugger (hereafter "Agent") failed to file an annual report with the Commissioner on or before April 1, 2014 and failed to remit required fees as stated in the Statement of Charges with Application for Suspension for Good Cause dated May 1, 2014 which is incorporated herein by reference. Seller and Agent consent to the entry of this Order. Seller and Agent admit that the Iowa Insurance Division has personal jurisdiction over them and has subject matter jurisdiction over this matter.

AGREEMENT

1. Censure of Preneed Seller license. Seller agrees to the censure of its preneed seller license in the state of Iowa based on the allegations made in this Order.

- 2. Censure of Preneed Sales Agent license. Agent agrees to the censure of his preneed sales agent license in the state of lowa based on the allegations made in this Order.
- 3. Cease and Desist Order. Seller and Agent agree to cease and desist further violations of Iowa Code Chapter 523A and its rules.
- 4. Filing of Annual Report. Seller and Agent agree to file their respective annual report prior to or upon the signing of this Order.
- 5. Civil Penalty. Seller and Agent agree to the payment of \$500 each payable upon the signing of this Order.
- 6. Reinstatement of licenses. The Division agrees to reinstate Seller and Agent's licenses upon the signing of this Order by the Commissioner. Seller and Agent's licenses were suspended pursuant to an Order of Suspension dated May 5, 2014 which is incorporated herein by reference.

ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code Chapter 523A that:

- 1. Seller is hereby censured.
- 2. Agent is hereby censured.
- 3. Seller and Agent shall cease and desist violating Iowa Code Chapter 523A and its rules.
- 4. Seller and Agent shall each file their respective annual report prior to or upon the signing of this Order.

5. Seller and Agent shall pay a civil penalty of \$500 each to the Division due upon the signing of this Order. The check totaling \$1,000 shall be made payable to the Iowa Insurance Division and remitted along with the signed Consent to Orders to the Iowa Insurance Division, Two Ruan Center, 601 Locust Street, 4th Floor, Des Moines, Iowa 50309 with attention to Robert Koppin, Enforcement Bureau Chief.

- 6. Seller and Agent's licenses shall immediately be reinstated.
- 7. Nothing contained in this Order shall in any way limit the right of the Division to institute administrative or legal action against Seller and Agent for any other past conduct or future activity in violation of lowa laws or regulations.
