- 2. Agent shall cease and desist violating lowa Code Chapter 523A and its rules.
- 3. The Order of Suspension is vacated and Agent's license shall immediately be reinstated.
- 4. Nothing contained in this Order shall in any way limit the right of the Division to institute administrative or legal action against Agent for any other past conduct or future activity in violation of Iowa laws or regulations.
