The Iowa Insurance Division ("Division") pursuant to the provisions of the Iowa Licensing of Insurance Producers Act – Iowa Code Chapter 522B has sought the entry of this Order.

PARTIES AND JURISDICTION

- 1. The Commissioner of Insurance, Nick Gerhart, enforces the Iowa Licensing of Insurance Producers Act, Iowa Code Chapter 522B, pursuant to Iowa Code § 505.8 (2013).
- 2. Jeffrey A. Ash ("Ash") is an individual with a last known mailing address of 10459 Juan Calle, Clive, IA 50325-6522.
- 3. Ash is a licensed insurance producer in the state of lowa.

FACTUAL ALLEGATIONS

- 4. The Division received a letter dated June 23, 2014 from Shelter Insurance Companies ("Shelter") advising the Division of Ash's termination for cause. Shelter stated that they discovered, after a loss, that Ash had backdated a policy change to provide coverage for the policyholder.
- 5. The Division sent Ash a letter on July 7, 2014 requiring Ash to send a written response to the termination for cause by Shelter. In his response, Ash admitted that he backdated a policy change to provide coverage for a newly acquired vehicle so a claim that had already occurred would be paid by Shelter.

STIPULATIONS

6. Jurisdiction. Ash consents to the entry of this Order and admits that the Iowa Insurance Division has personal jurisdiction over him and has subject matter jurisdiction over this matter.

7. Revocation of insurance producer license. Ash agrees to the revocation of his producer license in the state of lowa based on the allegations in this Order.

8. Bar on reapplying for license. Ash agrees not to reapply for a producer license in the state of lowa for five (5) years from the date of the commissioner's signature on this Order.

ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code Chapter 522B that:

- 1. Ash is hereby revoked.
- 2. Ash shall not reapply for an insurance producer license for five (5) years from the date this Order is signed by the Commissioner.
- 3. Nothing contained in this Order shall in any way limit the Division to institute administrative or legal action against Ash for any past conduct or future activity in violation of Iowa laws and regulations.
