ORDER AND CONSENT TO ORDER

The Iowa Insurance Division (“Division”), pursuant to the provisions of the Iowa Licensing of Insurance Producers Act – chapter 522B has sought the entry of this Order.

ALLEGATIONS OF FACT

The Division has alleged that Keith Mahoney (Mahoney) has violated Iowa Code section 522B.11(1)(a) by providing incorrect, misleading, incomplete, or materially untrue information on his license application. Specifically, the Division alleges that Mahoney did not disclose that he had been the subject of an Administrative proceeding with the Iowa Real Estate Commission in 2010.

STIPULATIONS


1. **Jurisdiction.** Mahoney consents to the entry of this Order and admits that the Iowa Insurance Division has personal jurisdiction over him and has subject matter jurisdiction over this matter.
2. **Cease and desist.** Mahoney consents to cease and desist from failing to timely report all future disclosable events to the Division.
3. **Payment of civil penalty.** Mahoney agrees to pay a civil penalty in the amount of \$250.


ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code Chapter 522B that:

1. Mahoney shall cease and desist from failing to timely report all future disclosable events to the Division.
2. Mahoney is ordered to pay a civil penalty in the amount of \$250. The check for \$250 should be made payable to the Iowa Insurance Division and mailed with the signed Order and Consent to Order addressed to the Iowa Insurance Division, 601 Locust Street, 4th Floor, Des Moines, Iowa 50309-3738 with attention to Emily Zach, Attorney.
3. Nothing contained in this Order shall in any way limit the right of the Division to institute administrative or legal action against Mahoney for any other past conduct or future activity in violation of Iowa laws or regulations.




