Now comes the Iowa Insurance Division ("Division") pursuant to the provisions of the Iowa Cemetery and Funeral Merchandise and Funeral Services Act - Iowa Code Chapter 523A and Iowa Administrative Code Chapters 191-103, 105 & 106. The Division alleges that Kasey S. Peterson (hereafter "Agent") failed to file an annual report with the Commissioner on or before April 1, 2014 and failed to remit required fees as stated in the Statement of Charges with Application for Suspension for Good Cause dated June 2, 2014 which is incorporated herein by reference. Agent cancelled his preneed sales agent license on September 1, 2014. Agent consents to the entry of this Order. Agent admits that the Iowa Insurance Division has personal jurisdiction over him and has subject matter jurisdiction over this matter.

AGREEMENT

- Censure of Preneed Sales Agent license. Agent agrees to the censure of his preneed sales agent license in the state of lowa based on the allegations made in this Order.
- 2. Cease and Desist Order. Agent agrees to cease and desist further violations of lowa Code Chapter 523A and its rules.

3. Filing of Annual Report. Agent agrees to file their annual report prior to or upon the signing of this Order.

4. Civil Penalty. Agent agrees to the payment of \$500 payable only if he reapplies for any license with the Division. The \$500 payment would be due and payable upon the application for any license with the Division.

ORDER

WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code Chapter 523A that:

- 1. Agent is hereby censured.
- Agent shall cease and desist violating Iowa Code Chapter 523A and its rules. 2.
- Agent shall file the 2014 annual report contemporaneous with the issuance of 3. this Order.
- Agent shall pay a civil penalty of \$500 to the Division only if he reapplies for any 4. license with the Division. The civil penalty of \$500 shall be due and payable upon the application for any license with the Division.
- Nothing contained in this Order shall in any way limit the right of the Division to 5. institute administrative or legal action against Agent for any other past conduct or future activity in violation of Iowa laws or regulations.
