The Iowa Insurance Division ("Division") pursuant to the provisions of the Iowa Licensing of Insurance Producers Act – Iowa Code Chapter 522B has sought the entry of this Order.

PARTIES AND JURISDICTION

1. The Commissioner of Insurance, Nick Gerhart, enforces the Iowa Licensing of Insurance Producers Act, Iowa Code Chapter 522B, pursuant to Iowa Code § 505.8 (2013).
2. John T. Clark ("Clark") is an individual with a last known mailing address of 956 Witman, Fort Myers, FL 33919.
3. Clark is licensed as a non-resident insurance producer in the state of Iowa since January 19, 2012. Prior to that date, Clark had been licensed as a resident insurance producer from June 8, 1985 through January 18, 2012.

FACTUAL ALLEGATIONS

4. Clark applied for a renewal of his insurance producer license to the Division by submitting through the National Insurance Producer Registry a Uniform Application for Individual Insurance Producer License ("Application") on January 26, 2011. In submitting the Application, Clark designated the Commissioner as an agent for service of process.
5. Clark, through his attorney, had agreed to and scheduled a sworn statement to be taken on November 4, 2014 at the office of the Iowa Insurance Division.
6. On November 4, 2014, the Division was informed by Clark's attorney that he would not be appearing for a sworn statement. Further, Clark's attorney stated that Clark would not

participate in the taking of a sworn statement to answer questions regarding his conduct of business in this state or elsewhere.

VIOLATION OF IOWA INSURANCE LAWS AND REGULATIONS

FAILURE OR REFUSAL TO COOPERATE WITH THE DIVISION'S INVESTIGATION

7. Paragraphs 1 – 6 are incorporated by reference.
8. Clark failed or refused to cooperate in an investigation by the Division in violation of Iowa Code § 522B.11(1)(p) (2013).
9. The violation of Iowa Code Chapter 522B and applicable rules is grounds for revocation, suspension, censure, and/or the imposition of a civil penalty and an order requiring such person to cease and desist from the acts, methods or practices stated in this statement of charges pursuant to Iowa Code §§522B.11 and 522B.17 (2013).

STIPULATIONS


10. Jurisdiction. Clark consents to the entry of this Order and admits that the Iowa Insurance Division has personal jurisdiction over him and has subject matter jurisdiction over this matter.
11. Revocation of insurance producer license. Clark agrees to the revocation of his non-resident producer license in the state of Iowa based on the allegations in this Order.
12. Bar on reapplying for a license. Clark further agrees to not reapply for a producer license in the state of Iowa for five (5) years from the date of the commissioner's signature on this Order.

ORDER


WHEREFORE, IT IS ORDERED pursuant to the powers granted to the Commissioner of Insurance by Iowa Code Chapter 522B that:

1. Clark is hereby revoked.
2. Clark shall not reapply for an insurance producer license in the state of Iowa for five (5) years from the date this Order is signed by the Commissioner.
3. Nothing contained in this Order shall in any way limit the Division to institute administrative or legal action against Clark for any past conduct or future activity in violation of Iowa laws and regulations.


