Pursuant to Iowa Code chapter 522B and 191 IAC 10.10, this matter comes before the Commissioner of Insurance upon an application by George D. Rudkin for the reinstatement of his Iowa insurance producer’s license.

I. PARTIES AND JURISDICTION

1. The Commissioner of Insurance, Nick Gerhart, directly and through his designees, administers and enforces the provisions of Iowa Code § 505.8 and the Iowa Licensing of Insurance Producers Act, Chapter 522B.

2. George D. Rudkin (“Rudkin”) is an individual with a last known mailing address of 5607 Rhode Island Avenue N, Minneapolis, MN 55428 and a national producer number of 17864029.

3. Rudkin has filed an application with the Iowa Insurance Division (“Division”) for reinstatement of his suspended license and the Commissioner is authorized to issue this Order pursuant to 191 IAC 10.10.

II. FINDINGS OF FACT

4. Rudkin is licensed as a nonresident insurance producer in the State of Iowa.

5. Rudkin submitted an application for individual insurance producer license on or about February 24, 2016, in which the Commissioner was designated as agent for service of process.

6. On June 15, 2016, the Division mailed Rudkin notification of the intent to issue a suspension of his license if the Iowa Department of Human Services (“DHS”) did not withdraw the Certificate of Noncompliance within 30 days.

7. On July 25, 2016, an order was issued by the Division immediately suspending Rudkin’s insurance producer’s license (“Suspension Order”). Rudkin was also notified that the Division’s reinstatement of the producer license was contingent upon DHS withdrawing the Certificate of Noncompliance.

8. DHS withdrew the Certificate of Noncompliance on August 1, 2016.

9. On August 2, 2016, Rudkin mailed an application for reinstatement after suspension of his insurance producer license as required by 191 IAC 10.10.

10. As Rudkin has complied with the Suspension Order and filed the necessary reinstatement application, an order of reinstatement of his Iowa insurance producer’s license should be issued.

III. CONCLUSIONS OF LAW

1. Iowa Code § 522B.11(1) authorizes a range of disciplinary actions for insurance producers, including suspensions, but the imposition and duration of suspensions, is within the discretion of the Commissioner.

2. Rudkin is in compliance with the conditions of the Suspension Order issued on July 25, 2016 and has filed the required application of reinstatement. An order of reinstatement should be issued pursuant to 191 IAC 10.10.

IV. ORDERS

IT IS THEREFORE ORDERED that:

A. The Suspension Order issued on July 25, 2016 is hereby vacated and the Iowa nonresident insurance producer license of Rudkin is reinstated; and

B. Rudkin shall immediately be permitted to transact and participate in the business of insurance in Iowa.

IT IS FURTHER ORDERED that, pursuant to Iowa Code § 505.8(10), the one hundred dollar (\$100) payment made with the application for reinstatement shall be paid to the Iowa Insurance Division settlement fund established for recovery of expenses and costs related to investigations and other proceedings.

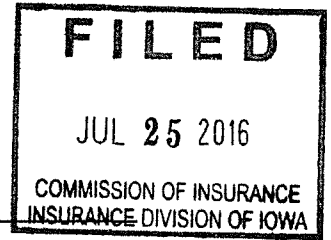

This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Human Services (“DHS”). **George D. Rudkin** (“Respondent”) submitted an application for insurance producer licensure in which the commissioner was designated as Respondent’s agent for service of process. Under Iowa Code section 252J.8 and Iowa Administrative Code, rule 191–10.21, the commissioner was required to issue a notice to Respondent advising that the Certificate of Noncompliance was received and that Respondent’s Iowa insurance producer license would be suspended in 30 days unless DHS withdrew the Certificate of Noncompliance within those 30 days. The Iowa Insurance Division’s letters notifying Respondent of the intended suspension were sent on June 15, 2016 and July 5, 2016. Therefore, the thirty-day notice period has now passed and DHS has not withdrawn the Certificate of Noncompliance. The commissioner has authority to order the suspension of the insurance producer license of Respondent pursuant to Iowa Code section 252J.8 and Iowa Administrative Code, rule 191–10.21.

IT IS THEREFORE ORDERED that:

The Iowa insurance producer license of **George D. Rudkin** is suspended as of the date of this Order.
