Pursuant to Iowa Code chapter 522B and 191 IAC 10.10, this matter comes before the Commissioner of Insurance upon an application by Shannon Brenton for the reinstatement of her Iowa insurance producer license.

I. PARTIES AND JURISDICTION

1. The Commissioner of Insurance, Nick Gerhart, directly and through his designees, administers and enforces the provisions of Iowa Code § 505.8 and the Iowa Licensing of Insurance Producers Act, chapter 522B.

2. Shannon Brenton (“Brenton”) is an individual with a last known mailing address of 4506 EP True Pkwy, Apt. 208, West Des Moines, IA 50265 and a national producer number of 18040188.

3. Brenton has filed an application with the Iowa Insurance Division (“Division”) for reinstatement of her suspended license and the Commissioner is authorized to issue this Order pursuant to 191 IAC 10.10.

II. FINDINGS OF FACT

4. Brenton is licensed as a resident insurance producer in the State of Iowa.

5. Brenton submitted an application for individual insurance producer license on or about July 29, 2016 in which the Commissioner was designated as agent for service of process.

6. On September 9, 2016 the Division mailed Brenton notification of the intent to issue a suspension of her license if the Iowa Department of Revenue (“IDR”) did not withdraw the Certificate of Noncompliance within 60 days.

7. On November 16, 2016, an order was issued by the Division immediately suspending Brenton’s insurance producer license (“Suspension Order”). Brenton was also notified that the Division’s reinstatement of the producer license was contingent upon IDR withdrawing the Certificate of Noncompliance.

8. IDR withdrew the Certificate of Noncompliance on November 22, 2016.

9. On November 28, 2016, Brenton filed an application for reinstatement after suspension of her insurance producer license as required by 191 IAC 10.10.

10. Brenton has complied with the terms of the Suspension Order.

III. CONCLUSIONS OF LAW

11. Iowa Code § 522B.11(1) authorizes a range of disciplinary actions for insurance producers, including suspensions, but the imposition and duration of suspensions, is within the discretion of the Commissioner.

12. 191 IAC 10.10(2)(a) states that a producer whose license has been suspended by order may apply to the Commissioner for reinstatement of his or her license by filing an application for reinstatement.

13. 191 IAC 10.10(2)(b) provides that applications for reinstatement must allege facts sufficient to enable the Commissioner to establish that the basis of the suspension no longer exists.

14. Brenton is in compliance with the conditions of the Suspension Order issued on November 16, 2016.

15. Brenton and has filed the required application for reinstatement and has alleged facts that demonstrate that the basis of the suspension no longer exists. An order of reinstatement should be issued pursuant to 191 IAC 10.10.

IV. ORDER

IT IS THEREFORE ORDERED that:

A. Brenton's suspension is terminated and her Iowa resident insurance producer license is reinstated; and

B. Brenton shall immediately be permitted to transact and participate in the business of insurance in Iowa.

IT IS FURTHER ORDERED that, pursuant to Iowa Code § 505.8(10), the one hundred dollar (\$100) payment remitted with the application for reinstatement shall be paid to the Iowa Insurance Division Enforcement Fund to provide funds for insurance enforcement and education.



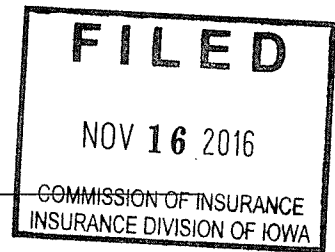

This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Revenue (“Revenue”). **Shannon Brenton** (“Respondent”) submitted an application for insurance producer licensure in which the Commissioner was designated as Respondent’s agent for service of process. Under Iowa Code section 272D.8 and Iowa Administrative Code, rule 191–10.23, the Commissioner was required to issue a notice to Respondent advising that the Certificate of Noncompliance was received and that Respondent’s Iowa insurance producer license would be suspended in 60 days unless Revenue withdrew the Certificate of Noncompliance within those 60 days. The Iowa Insurance Division’s letters notifying Respondent of the intended suspension were sent on September 9, 2016. Therefore, the sixty-day notice period has now passed and Revenue has not withdrawn the Certificate of Noncompliance. The Commissioner has authority to order the suspension of the insurance producer license of Respondent pursuant to Iowa Code section 272D.8 and Iowa Administrative Code, rule 191–10.23.

IT IS THEREFORE ORDERED that:

The Iowa insurance producer license of **Shannon Brenton** is suspended as of the date of this Order.

IT IS FURTHER ORDERED that:

Shannon Brenton shall not be eligible to have her license reinstated, reissued, renewed, or

to have a new license issued until each of the following has occurred:

1. Revenue issues a Withdrawal of the Certificate of Noncompliance;
2. Respondent makes the appropriate Application for Reinstatement or Reissuance,
which is approved by the Commissioner or his designee;
3. Respondent pays all applicable fees; and
4. Respondent complies with all other insurance statutes and regulations.
