Pursuant to Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code Chapter 10, this matter comes before the Commissioner of Insurance upon an application by Dean E. Olberding for reissuance of an Iowa insurance producer license.

I. PARTIES AND JURISDICTION

- 1. The Commissioner of Insurance, Doug Ommen, directly and through his designees, administers and enforces Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code Chapter 10, pursuant to Iowa Code § 505.8.
- 2. Dean E. Olberding ("Applicant") is an individual with a last known mailing address of 2035 E. Iron Ave., Salina, KS 67401 and a National Producer Number of 8177159.
- 3. Applicant has filed an application with the Iowa Insurance Division ("Division") for reissuance of his Iowa insurance producer license and filed an application through the National Insurance Producer Registry (NIPR) for individual producer license.
- 4. The Commissioner is authorized to issue this order pursuant to Iowa Administrative Code rule 191—10.10.

II. FINDINGS OF FACT

5. Applicant was previously licensed as a nonresident insurance producer in Iowa from December 26, 2006 until September 27, 2009.

- 6. Applicant was previously licensed as a resident insurance producer in Iowa from September 28, 2009 until September 26, 2011.
- 7. Applicant was again licensed as a nonresident insurance producer in Iowa from September 27, 2011 until November 30, 2012.
- 8. On March 22, 2012, the Division received a certificate of noncompliance from the Iowa Department of Human Services ("Certificate of Noncompliance") indicating that Applicant was not in compliance with a support order being enforced by the Child Support Recovery Unit ("CSRU").
- 9. On March 30, 2012, the Division mailed Applicant notification of the intent to suspend his insurance producer license if the CSRU did not issue a withdrawal of the Certificate of Noncompliance within thirty days.
- 10. On May 4, 2012, the Division issued an order immediately suspending Applicant's Iowa insurance producer license ("Suspension Order"). Applicant was also notified by letter that the reinstatement of his Iowa insurance producer license was contingent upon the CSRU issuing a withdrawal of the Certificate of Noncompliance and meeting the Division's requirements for reinstatement.
- 11. On November 30, 2012, Applicant's Iowa insurance producer license expired.
- 12. On September 8, 2015, the CSRU issued a notice of withdrawal of certificate of noncompliance for Applicant ("Withdrawal").
- 13. On February 10, 2017, Applicant applied for a nonresident insurance producer license with the Division by submitting through NIPR a Uniform Application for Individual Insurance Producer License ("Uniform Application").

14. On February 17, 2017, Applicant filed an Iowa insurance producer application for reissuance ("Reissuance Application"), which included a statement that the child support obligation has been met and the CSRU has issued the Withdrawal.

III. CONCLUSIONS OF LAW

- 15. Iowa Code § 522B.11(1) authorizes a range of disciplinary actions for insurance producers, including suspensions.
- 16. Iowa Administrative Code 191—10.10(6) provides that when a suspension of a producer's license extends beyond the license expiration date, the license terminates on the license expiration date.
- 17. Iowa Administrative Code 191—10(9)(2) provides that a nonresident producer who fails to receive a reinstatement of an expired license within 12 months of the license expiration date must apply for a new license.
- 18. Applicant is in compliance with the terms of the Suspension Order and has submitted a Reissuance Application.
- 19. Applicant has met his burden of establishing that the basis for the suspension, his noncompliance with the CSRU, no longer exists.
- 20. Applicant should be issued a new nonresident insurance producer license.

IV. ORDER

IT IS THEREFORE ORDERED that:

- A. Dean E. Olberding's Reissuance Application is granted and the administrative suspension block is removed from his Iowa licensing record;
- B. Dean E. Olberding's Uniform Application for Individual License Registration is approved;

This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Human Services ("DHS"). Under Iowa Code section 272J.9 (2011) and Iowa Administrative Code, rule 191-10.20, the Iowa Insurance Commissioner was required to issue a notice to **Dean Olberding** ("Respondent") advising Respondent that the Certificate of Noncompliance was received and that Respondent's Iowa insurance producer license would be suspended in 30 days unless DHS withdrew the Certificate of Noncompliance within those 30 days. The Iowa Insurance Division's letter notifying Respondent of the intended suspension was sent on March 30, 2012. Therefore, the thirty-day notice period has now passed.

The Iowa Insurance Commissioner has authority to order the suspension of the insurance producer license of Respondent pursuant to Iowa Code section 252J.8 (2011) and Iowa Administrative Code, rule 191-10.20.

THEREFORE, IT IS ORDERED:

The Iowa insurance producer license of Dean Olberding is suspended as of the date of this Order.
