REGULATORY AGREEMENT

NOW THEREFORE, upon motion of the Iowa Insurance Division ("Division") and consent of Respondents Ryan Fredregill and Fredregill Family Funeral Home, Inc., ("Respondents"), pursuant to the provisions of Iowa Code Chapter 523A—Iowa Cemetery and Funeral Merchandise and Funeral Services Act, the Commissioner enters the following Regulatory Agreement ("Agreement"):

I. PARTIES AND JURISDICTION

 The Commissioner of Insurance, Doug Ommen, administers Iowa Code Chapter 523A— Iowa Cemetery and Funeral Merchandise and Funeral Services Act pursuant to Iowa Code § 523A.801. Commissioner Ommen has designated the Iowa Insurance Division to seek enforcement of these provisions.

2. Ryan Fredregill is an individual and was licensed in the state of Iowa as a resident insurance producer from March 17, 2010 until September 30, 2013 under National Producer Number 15706394. Mr. Fredregill was licensed in the state of Iowa as a preened sales agent from May 20, 2010 to July 31, 2014 under Sales Agent Number SA-00830.

3. Mr. Fredregill is president and owner of Co-Respondent Fredregill Family Funeral Home, Inc., an Iowa corporation licensed in the state of Iowa as a preneed seller since June 7, 2010 under Preneed Seller Number PS-000302.

4. Fredregill Family Funeral Home, Inc. is and has been licensed in Iowa as a business entity producer since December 18, 2013 under Business Entity Producer 1002223626.

5. Respondents have a last-known mailing address of 107 E. Fox, Baxter, Iowa 50028.

II. FINDINGS OF FACT

6. Mr. Fredregill entered an Order and Consent to Order ("Order") with the Division on August 20, 2014 for failing to file an annual report and failing to remit required fees.

7. The Order censured Mr. Fredregill's preneed sales agent license and ordered him to pay a civil penalty of \$500.00 if he ever reapplied for a license with the Division.

8. On or about March 10, 2016, Respondents purchased real estate associated with Fredregill Enterprises, LLC ("Enterprises"), a limited liability company incorporated in the state of Iowa with a last-known business address of 310 N. Center St., Zearing, Iowa 50278.

Fredregill Enterprises, LLC was administratively dissolved pursuant to Iowa Code §
 489.705, effective August 14, 2017, for failing to deliver the required biennial report.

10. During the purchase, Respondents failed to purchase or legally assume Enterprises's existing preneed sales contracts.

III. AGREEMENT

NOW THEREFORE, the parties agree to the following:

A. Respondent Ryan Fredregill shall, within thirty days from the date of this Agreement, reapply for his preneed sales agent license with the Division. In addition to any relevant application fees, Ryan Fredregill shall, pursuant to the terms of the August

2014 Order, pay a civil penalty in the amount of \$500.00 due at the time of his application for his preneed sales agent license. The civil penalty shall be made to the order of the Iowa Insurance Division, to be credited to the Insurance Division Regulatory Fund to provide funds for expenses of examinations, investigations, consumer education, receiverships and any other appropriate uses authorized by Iowa Code Chapter 523A;

- B. Respondents shall, within four months from the date of this Agreement, provide proof that Respondents have completed one of the following:
 - Respondents acquired legal ownership of Enterprises's existing preneed contracts. Pursuant to Iowa Code § 523A.207, Respondents shall file with the Division an audit performed by a certified public accountant to assess the funding adequacy related to the purchase agreements to be transferred; or
 - Respondents entered into agreements with all impacted consumers whereby Respondents agree to provide all of the services specified in the relevant existing preneed contract.
- C. In the event of the death of any impacted consumer prior to the completion of the transfer of legal ownership of the existing contracts or prior to the completion of a new agreement as oùtlined in subsection B of this Agreement, Respondents shall provide all of the services specified in the relevant existing preneed contract; and
- D. Respondents shall file the new and/or existing contracts to the Division as part of the required annual report due April 15, 2018.
