Pursuant to Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code rule 191—10.10, this matter comes before the Commissioner of Insurance upon an application by Tommy McCellan-Bey for the reinstatement of his Iowa insurance producer license.

I. PARTIES AND JURISDICTION

- 1. The Commissioner of Insurance, Douglas Ommen, directly and through his designees, administers and enforces the provisions of Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code Chapter 10—Insurance Producer Licenses and Limited Licenses, pursuant to Iowa Code § 505.8.
- 2. Tommy McCellan-Bey ("Applicant") is an individual with a last known mailing address of 1400 N Barclay Street Waterloo, Iowa 50703 and a National Producer Number of 8945829.
- 3. Applicant filed an application with the Iowa Insurance Division ("Division") for reinstatement of his suspended Iowa insurance producer license.
- 4. The Commissioner is authorized to issue this Order pursuant to Iowa Administrative Code rule 191—10.10.

II. FINDINGS OF FACT

- 5. Applicant is and has been licensed as a resident insurance producer in the state of Iowa since October 17, 2006. Applicant's insurance producer license will expire on May 31, 2021. His license was suspended by a Findings of Fact, Conclusions of Law, and Final Orders on October 12, 2018 ("Final Order").
- 6. Per the terms of the Final Order, Applicant's license was suspended for ninety days and was ordered to pay costs of the investigation and prosecution in the amount of \$2,000.00.
- The Division received Applicant's payment of the ordered costs on February 15,
 2018.
 - 8. The ninety day suspension period has now passed.
- 9. On February 18, 2019, Applicant filed an "Application for Reinstatement of Producer License" that he appeared to have drafted himself. At that time the Division contacted him and informed him he was required to complete the Iowa Insurance Producer Application for Reinstatement ("Reinstatement Application") found online and submit the \$100.00 administrative fee.
- 10. Applicant then filed the Reinstatement Application on February 26, 2019 and submitted a required payment.
 - 11. Respondent has complied with the Final Order.

III. CONCLUSIONS OF LAW

12. Iowa Administrative Code rule 191—10.10(2)(a) states that a producer whose license has been suspended by order may apply to the Commissioner for reinstatement of his or

her license by filing an application for reinstatement. The applicant shall initiate the proceedings for reinstatement by filing an application for reinstatement with the Commissioner.

- 13. Iowa Administrative Code rule 191—10.10(2)(b) states that applications for reinstatement must allege facts sufficient to enable the Commissioner to establish that the basis of the suspension no longer exists.
- 14. Applicant has filed the application for reinstatement required by Iowa Administrative Code rule 191—10.10(2)(a).
 - 15. Applicant is in compliance with the terms of the Final Order.
- 16. Applicant has met his burden of establishing that the basis for the suspension no longer exists.
- 17. Applicant has met all requisites for the issuance of an Iowa resident insurance producer license under Iowa Administrative Code Chapter 10.

IV. ORDER

IT IS THEREFORE ORDERED that:

- A. Applicant's Reinstatement Application is granted and his license is hereby reinstated; and
- B. Applicant shall immediately be permitted to transact and participate in the business of insurance in Iowa.

IT IS FURTHER ORDERED that, pursuant to Iowa Code § 505.8(10), the one hundred dollar (\$100) payment remitted with the Reinstatement Application for administrative costs shall be paid to the Iowa Insurance Division Enforcement Fund to provide funds for insurance enforcement and education.
