Now comes the Iowa Insurance Division ("Division") pursuant to the provisions of the Iowa Insurance Division Act - Iowa Code Chapter 505, the Iowa Insurance Trade Practices Act – Iowa Code Chapter 507B and the Iowa Insurance Other Than Life Act - Chapter 515 and enters into the following Order and Consent to Order ("Consent Order"):

I. PARTIES AND JURISDICTION

- 1. The Commissioner of Insurance, Doug Ommen, directly or through his designees, pursuant to Iowa Code § 505.8 (2019), administers and enforces the Iowa Insurance Division Act Iowa Code Chapter 505, the Iowa Insurance Trade Practices Act Iowa Code Chapter 507B and the Iowa Insurance Other Than Life Act Iowa Code Chapter 515. Commissioner Ommen has designated James N. Armstrong as Deputy Commissioner of Supervision.
- 2. AXA Insurance Company ("AXA") is a New York corporation with a last known mailing address of 200 Liberty Street, New York, NY 10281, Attn: Donna Nadeau, Chief Executive Officer.
- 3. AXA is and has been issued a Certificate of Authority with the Division since April 22, 1991.

II. FINDINGS OF FACT

- 4. The Division issued AXA a Certificate of Authority on April 22, 1991 and assigned NAIC number 33022.
- 5. AXA filed a Uniform Consent to Service of Process (the "Consent") on January 19, 2006. In submitting the Consent, AXA designated the Commissioner as an agent for service of process.
- 6. On November 2, 2018, the Division emailed the Government Relations Contact person at AXA reported by the Company in its Quarterly electronic financial statement filed with and maintained by the National Association of Insurance Commissioners ("NAIC"), to request written information reflecting dram shop liability insurance in the state of Iowa. The Division's email stated that the dram shop liability insurance information for the years 2016 and 2017 was due to the Division's contact person on or before December 12, 2018 and for the year 2018 was due on or before February 11, 2019. No response was received to the email.
- 7. On January 16, 2019, the Division emailed a second substantially identical request to the Government Relations Contract person at AXA. At the top of the email was a statement "SECOND REQUEST DUE IMMEDIATELY." No response was received to the email.
- 8. On April 3, 2019, a letter was sent by certified mail to the Chief Executive Officer of AXA providing directions on how to respond to the evaluation of dram shop liability insurance in Iowa. The letter stated that there had been no response to the previous emails sent to the Government Relations Contact person. The letter further advised that "A written response to this letter is due within 20 days of the receipt of this letter. A failure to comply with the instructions in this letter may result in administrative action being taken against the company."
- According to the United States Postal Service Tracking website, the certified letter was delivered on April 9, 2019. No response has been received to the previous emails or to the certified letter.

- 10. On May 20, 2019, a Notice of Hearing was issued to AXA by the Iowa Department of Inspections and Appeals. The Notice of Hearing contained an attached Statement of Charges alleging a failure to timely respond to the Division's inquiry.
- 11. On May 29, 2019, the Division received the requested response to its inquiry by email.

III. VIOLATION

- 12. Paragraphs 1-11 are incorporated by reference.
- 13. AXA did not promptly respond to inquiries from the commissioner within thirty days of the receipt of the inquiry.
- 14. AXA's acts and practices have been in violation of lowa Code § 507B.4A subjecting it to a civil penalty, an order requiring it to cease and desist from engaging in such acts or practices, and any other corrective action the Commissioner deems necessary and appropriate pursuant to lowa Code §§ 505.7A, 505.8(10), 505.33, 507B.4A, 507B.6, 507B.7 and 515.144 (2019).

IV. ORDER

WHEREFORE, IT IS ORDERED, pursuant to the powers granted to the Division pursuant to lowa Code Chapters 505, 507B and 515.

- A. AXA Insurance Company shall cease and desist engaging in the acts or practices alleged herein pursuant to Iowa Code §§ 507B.7.
- B. AXA Insurance Company shall, upon the signing of the Consent Order, pay a civil penalty in the amount of \$500 by check made payable to the Iowa Insurance Division. The check and signed Consent Order should be sent to the attention of Robert Koppin, Company Regulation Counsel, Iowa Insurance Division, Two Ruan Center, 601 Locust Street, 4th Floor, Des Moines, Iowa 50309-3738.

C. Nothing contained in this Order shall in any way limit the right of the Division to institute administrative or legal action against AXA Insurance Company for any other past conduct or future activity in violation of Iowa laws or administrative rules.
