Pursuant to Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code rule 191—10.10, this matter comes before the Commissioner of Insurance upon an application by Trina Gomez for the reinstatement of his Iowa insurance producer license.

I. PARTIES AND JURISDICTION

1. The Commissioner of Insurance, Douglas M. Ommen, directly and through his designees, administers and enforces the provisions of Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code Chapter 10—Insurance Producer Licenses and Limited Licenses, pursuant to Iowa Code § 505.8.

2. Trina Gomez (“Applicant”) is an individual with a last known mailing address of 221 E Church Street, Polk City, Iowa 50226 and a National Producer Number of 7237159.

3. Applicant filed an application with the Iowa Insurance Division (“Division”) for reinstatement of her suspended Iowa insurance producer license.

4. The Commissioner is authorized to issue this Order pursuant to Iowa Administrative Code rule 191—10.10.

II. FINDINGS OF FACT

5. Applicant is and has been licensed as a resident insurance producer in the state of Iowa since May 8, 2002. Applicant’s insurance producer license will expire on February 29,

2020. Her license was suspended by a Findings of Fact, Conclusions of Law, and Final Orders issued by the Iowa Insurance Commissioner on January 16, 2019 (“Final Order”).

6. Per the terms of the Final Order, Applicant’s license was suspended for six months effective February 1, 2019 through July 31, 2019, and she was ordered to pay costs of the investigation and prosecution in the amount of \$1,000.00.

7. The Applicant paid the ordered costs to the Iowa Department of Revenue (“IDR”) after the file was referred for collection. Confirmation of payment was received from IDR on August 9, 2019.

8. The suspension period has now passed.

9. Applicant submitted an Iowa insurance producer application for reinstatement (“Reinstatement Application”) filed August 8, 2019 and submitted the required payment.

10. Respondent has complied with the Final Order.

III. CONCLUSIONS OF LAW

11. Iowa Administrative Code rule 191—10.10(2)(a) states that a producer whose license has been suspended by order may apply to the Commissioner for reinstatement of his or her license by filing an application for reinstatement. The applicant shall initiate the proceedings for reinstatement by filing an application for reinstatement with the Commissioner.

12. Iowa Administrative Code rule 191—10.10(2)(b) states that applications for reinstatement must allege facts sufficient to enable the Commissioner to establish that the basis of the suspension no longer exists.

13. Applicant has filed the application for reinstatement required by Iowa Administrative Code rule 191—10.10(2)(a).

14. Applicant is in compliance with the terms of the Final Order.

15. Applicant has met her burden of establishing that the basis for the suspension no longer exists.

16. Applicant has met all requisites for the issuance of an Iowa resident insurance producer license under Iowa Administrative Code Chapter 10.

IV. ORDER

IT IS THEREFORE ORDERED that:

A. Applicant's Reinstatement Application is granted and her license is hereby reinstated; and

B. Applicant shall immediately be permitted to transact and participate in the business of insurance in Iowa.

IT IS FURTHER ORDERED that, pursuant to Iowa Code § 505.8(10), the one hundred dollar (\$100) payment remitted with the Reinstatement Application for administrative costs shall be paid to the Iowa Insurance Division Enforcement Fund to provide funds for insurance enforcement and education.
