This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Revenue ("Revenue").

- 1. Kevin Meyers ("Respondent") submitted an application for insurance producer licensure designating the Commissioner as Respondent's agent for service of process and was issued a nonresident producer license under National Producer Number 9673465.
- 2. Pursuant to Iowa Code § 272D.8 and Iowa Administrative Code rule 191—10.23, the Commissioner issued a notice to Respondent advising that the Certificate of Noncompliance was received and that Respondent's nonresident insurance producer license would be suspended in 60 days unless Revenue withdrew the Certificate of Noncompliance.
- 3. The Iowa Insurance Division mailed the letter notifying Respondent of the intended suspension by restricted certified mail, return receipt requested, and by regular first class mail on December 20, 2019 to the address listed in his licensing record, as well as to an address provided by Revenue.
- 4. The notice mailed restricted certified to the address listed in the licensing record has was returned to the Division December 27, 2019, marked "Return to Sender Not Deliverable as Addressed Unable to Forward."
- 5. The regular first class mailing to the address listed in the licensing record was also returned to the Division December 27, 2019, also marked "Return to Sender Not Deliverable as Addressed Unable to Forward."

6. The notice mailed restricted certified to the address provided by Revenue was returned to the Division on January 13, 2020, marked "Return to Sender – Unclaimed – Unable to Forward."

7. The regular first class mailing to the address provided by Revenue has not been returned to date.

8. The 60 day notice period has now passed and Revenue has not withdrawn the Certificate of Noncompliance.

9. The Commissioner has authority to order the suspension of the insurance producer license of Respondent pursuant to Iowa Code § 272D.8 and Iowa Administrative Code rule 191—10.23.

IT IS THEREFORE ORDERED that the Iowa nonresident insurance producer license of Kevin Meyers is suspended as of the date of this Order.

IT IS FURTHER ORDERED that Kevin Meyers shall not be eligible for license reinstatement, reissuance, or renewal until all of the following has occurred:

1. Revenue issues a Withdrawal of the Certificate of Noncompliance;

2. Respondent makes the appropriate Application for Reinstatement or Reissuance and this application is approved by the Commissioner or his designee;

3. Respondent pays all applicable fees; and

4. Respondent complies with all other insurance statutes and regulations.
