This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Human Services (“DHS”).

1. Pursuant to Iowa Code § 252J.8 and Iowa Administrative Code rule 191—10.21, Adam Ross’s (“Respondent”) Iowa insurance producer license under National Producer Number 17545226 was suspended on July 29, 2019 after submission of a Certificate of Noncompliance from the Iowa Department of Human Services (DHS).

2. Respondent seemingly complied with the terms of that suspension order including DHS issuing a withdrawal of the Certificate of Noncompliance, making the appropriate Application for Reinstatement, paying all applicable fees, and complying with all other insurance statutes and regulations. Respondent’s license was reinstated in an Order Reinstating License After Suspension filed August 7, 2019.

3. However, on September 5, 2019 the Iowa Insurance Division was informed by the Iowa Utilities Board Accounting Division that the check received with Respondent’s license reinstatement application was returned for nonsufficient funds.

4. Iowa Administrative Code rule 191—10.6(4)(522B), states,

If the division issues or renews a producer license and subsequently determines that payment for the license or renewal was returned to the division by a bank without payment, or that the credit card company does not approve or cancels or refuses amounts charged to the credit card, the license shall be immediately suspended until the payments are made and any fees or penalties charged by the division are paid, at which time the license may be reinstated. The individual

may request a hearing within 30 days of receipt of notice by the division that the license was suspended.

IT IS THEREFORE ORDERED that the Order Reinstating License After Suspension filed August 7, 2019 is hereby rescinded as of the date of this order.

IT IS THEREFORE ORDERED that the Iowa insurance producer license of Adam Ross is suspended as of the date of this Order.


IT IS FURTHER ORDERED that Adam Ross shall not be eligible for license reinstatement, reissuance, renewal, or to have a new license issued until his license reinstatement payment is received and processed.
