WHEREAS, pursuant to Iowa Code § 523A.809(1), the Commissioner may issue orders necessary or appropriate for the protection of purchasers and the public and to administer the provisions of Iowa Code chapter 523A;

WHEREAS, pursuant to Iowa Code sections 523A.204(1) and 523A.502A(1), preneed sellers and sales agents are required to file annual reports by April 1;

WHEREAS, pursuant to Iowa Code sections 523A.501(7) and 523A.502(5), preneed seller and sales agent licenses are set to expire April 15 if no report is filed;

WHEREAS, pursuant to Iowa Code section 523I.813 and Iowa Administrative Code rule 191—101.9(1), perpetual care cemeteries must file annual reports by April 30;

WHEREAS, Iowa Governor Kim Reynolds has issued proclamations continuing the State Public Health Emergency Declaration in response to the coronavirus pandemic;

WHEREAS, the Commissioner previously extended the deadline to file the preneed annual reports and the related license expiration for preneed sellers and sales agents to April 30;

WHEREAS, Iowa Governor Kim Reynolds issued another Proclamation of Disaster Emergency on April 27, 2020 that extended the State of Public Health Disaster Emergency and ordered certain relief and prohibitions be extended until to May 15, 2020;

WHEREAS, the declared public health disaster that continues in the state of Iowa may cause preneed sellers, sales agents, and perpetual care cemeteries to be delayed in the filing of their annual reports; and

NOW THEREFORE, the Commissioner finds it necessary or appropriate in the public interest to extend the deadline for preneed sellers, sales agents, and perpetual care cemeteries to file their annual report until May 29, 2020.

IT IS ORDERED that the Commissioner extends the deadline for preneed sellers, sales agents, and perpetual care cemeteries to file their 2019 annual report until May 29, 2020. The Commissioner encourages preneed sellers, sales agents, and perpetual care cemeteries to use the extended time period to submit their annual reports.

IT IS FURTHER ORDERED that the Commissioner extends the license expiration date of Iowa Code sections 523A.501(7) and 523A.502(5) for preneed sellers and sales agents to June 5, 2020.
