Pursuant to Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code rule 191—10.10, this matter comes before the Commissioner of Insurance upon an application by Lawrence L. Roberts for the reinstatement of his Iowa insurance producer license.

**I. PARTIES AND JURISDICTION**

1. The Commissioner of Insurance, Douglas Ommen, directly and through his designees, administers and enforces the provisions of Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code Chapter 10—Insurance Producer Licenses and Limited Licenses, pursuant to Iowa Code § 505.8.

2. Lawrence L. Roberts (“Roberts”) is an individual with a last-known residence, business, and mailing address of 3209 NE Huntington Lane, Ankeny 50021.

3. Applicant filed an application with the Iowa Insurance Division (“Division”) for reinstatement of his suspended Iowa insurance producer license.

4. The Commissioner is authorized to issue this Order pursuant to Iowa Administrative Code rule 191—10.10.

## **II. FINDINGS OF FACT**

5. Roberts is and has been licensed in the State of Iowa as a resident insurance producer since June 29, 2017. He is licensed under National Producer Number 6865756.

6. Roberts' insurance producer license will expire on October 31, 2020. His license was suspended by a consent order entered between the Applicant and the Division on May 6, 2020 ("Consent Order").

7. Per the terms of the Consent Order, Applicant's license was suspended for two months, was ordered to pay a civil penalty in the amount of \$1,000.00, was ordered to pay costs of the investigation and prosecution in the amount of \$2,000.00, and Roberts was ordered to complete 12 hours of continuing education.

8. The Division received Applicant's payment of the ordered civil penalty and costs on May 5, 2020 and Applicant's continuing education completion certificates on May 18, 2020.

9. The suspension period has now passed.

10. Applicant submitted an Iowa insurance producer application for reinstatement ("Reinstatement Application") dated July 6, 2020.

11. The Division has reviewed the Reinstatement Application.

12. Applicant indicated on his application that he has spent his time during suspension increasing his knowledge of Medicare and Medicaid.

## **III. CONCLUSIONS OF LAW**

13. Iowa Administrative Code rule 191—10.10(2)(a) states that a producer whose license has been suspended by order may apply to the Commissioner for reinstatement of his or her license by filing an application for reinstatement. The applicant shall initiate the proceedings for reinstatement by filing an application for reinstatement with the Commissioner.

14. Iowa Administrative Code rule 191—10.10(2)(b) states that applications for reinstatement must allege facts sufficient to enable the Commissioner to establish that the basis of the suspension no longer exists.

15. Applicant has filed the application for reinstatement required by Iowa Administrative Code rule 191—10.10(2)(a).

16. Applicant is compliant with the terms of the Consent Order.

17. Applicant has met his burden of establishing that the basis for the suspension no longer exists.

18. Applicant has met all requisites for the issuance of an Iowa resident insurance producer license under Iowa Administrative Code Chapter 10.

#### **IV. ORDER**

**IT IS THEREFORE ORDERED** that:


A. Applicant's Reinstatement Application is granted and his license is hereby reinstated; and

B. Applicant shall immediately be permitted to transact and participate in the business of insurance in Iowa.

**IT IS FURTHER ORDERED** that, pursuant to Iowa Code § 505.8(10), the one hundred dollar (\$100) payment remitted with the Reinstatement Application for administrative costs shall be paid to the Iowa Insurance Division Enforcement Fund to provide funds for insurance enforcement and education.
