ORDER REISSUING LICENSE AFTER REVOCATION

Pursuant to Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code Chapter 10, this matter comes before the Commissioner of Insurance upon an application by Reynaldo Castillo for the reissuance of his Iowa insurance producer license.

I. PARTIES AND JURISDICTION

1. The Commissioner of Insurance, Doug Ommen, directly and through his designees, administers and enforces Iowa Code chapter 522B—Licensing of Insurance Producers

and Iowa Administrative Code chapter 10, pursuant to Iowa Code § 505.8.

2. Reynaldo Castillo ("Applicant") is an individual with a last known mailing address of 2050 Seefield Street, PO Box 654, Alvord, Iowa 51230 and a National Producer Number of 9037497.

3. Applicant has filed an application with the Iowa Insurance Division ("Division") for reissuance of his revoked Iowa insurance producer license and filed an application through the National Insurance Producer Registry (NIPR) for individual producer license.

4. The Commissioner is authorized to issue this Order pursuant to Iowa Administrative Code rule 191—10.10.

II. FINDINGS OF FACT

5. Applicant was previously licensed as a resident insurance producer in Iowa from January 16, 2007 until April 18, 2012, when his license was revoked by an Order and Consent to Order ("Consent Order") entered between Applicant and the Division.

6. On June 15, 2021, Applicant filed an Iowa Insurance Producer Application for Reinstatement or Reissuance After Disciplinary Action ("Reissuance Application").

7. The Division's Producer Licensing Bureau confirmed that Applicant has successfully passed the health exam.

III. CONCLUSIONS OF LAW

8. Iowa Code § 522B.11(1) authorizes a range of disciplinary actions for insurance producers, including revocation.

9. Iowa Administrative Code 191—10.10(2)(a) states that a producer whose license has been revoked by order may apply to the Commissioner for reissuance of his or her license by filing an application for reissuance.

10. Applicant is in compliance with the terms of the Consent Order and has submitted a Reissuance Application.

11. Applicant has met his burden of establishing that the basis for the revocation no longer exists.

12. Applicant has met all requisites for the reissuance of an Iowa resident insurance producer license under Iowa Code chapter 522B and Iowa Administrative Code chapter 10.

IV. ORDER

IT IS THEREFORE ORDERED that:

A. Reynaldo Castillo's Reissuance Application is granted and the administrative revocation block shall be removed from his licensing record; and

B. Reynaldo Castillo's Uniform Application for Individual License Registration is approved.
