Pursuant to Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code Chapter 10, this matter comes before the Commissioner of Insurance upon an application by Brodie L. Thomas for reissuance of his Iowa insurance producer license.

I. PARTIES AND JURISDICTION

- 1. The Commissioner of Insurance, Doug Ommen, directly and through his designees, administers and enforces Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code Chapter 10, pursuant to Iowa Code § 505.8.
- 2. Brodie L. Thomas ("Applicant") is an individual with a last known mailing address of 3901 83rd St., Urbandale, IA 50322, and a National Producer Number of 7844371.
- 3. Applicant has filed an application with the Iowa Insurance Division ("Division") for reissuance of Applicant's Iowa resident insurance producer license and filed an application through the National Insurance Producer Registry ("NIPR") for individual producer license.
- 4. The Commissioner is authorized to issue this order pursuant to Iowa Administrative Code rule 191—10.10.

II. FINDINGS OF FACT

5. Applicant was previously licensed as a resident insurance producer in Iowa from September 3, 2003, until his license was suspended on November 16, 2011, for failure to pay state debt.

- 6. In 2011, the Division received a Certificate of Noncompliance from the Iowa Department of Revenue ("IDR") indicating that Applicant had outstanding state debt.
- 7. On August 16, 2011, pursuant to Iowa Code § 272D.9 (2011) and Iowa Administrative Code rule 191—10.23 (2011), the Division sent Applicant a letter notifying Applicant of its intention to suspend his resident insurance producer license.
- 8. On September 14, 2011, the Division sent a second notice of intended suspension.
- 9. On November 16, 2011, following expiration of the required sixty-day notice period, the Commissioner entered an order suspending Applicant's insurance producer license pursuant to Iowa Code section 252J.9 (2011)¹ and Iowa Administrative Code rule 191—10.23.
- 10. Applicant's license expired on July 31, 2012, while still on suspended status.
- 11. On April 2, 2014, IDR withdrew the Certificate of Noncompliance regarding Applicant.
- 12. On April 25, 2024, Applicant submitted an Iowa insurance producer application for reinstatement or reissuance after disciplinary action.
- 13. The Division's Product and Producer Licensing Bureau reviewed Applicant's application and determined that the reason for Applicant's suspension has been satisfied and that there exist no other grounds to deny Applicant's license at this time.

III. CONCLUSIONS OF LAW

- 14. Iowa Code § 272D.3 authorizes a range of disciplinary actions for licensees for whom a Certificate of Noncompliance has been issued, including suspension.
- 15. Iowa Administrative Code rule 191—10.10(2)(a) states that a producer whose license has been suspended by order may apply to the Commissioner for reissuance of his or her license by filing an application for reissuance.

¹ The order references Iowa Code chapter 252J, which relates specifically to child support, but the Certificate of Noncompliance from IDR and IDR's withdrawal of said certificate only reference chapter 272D.

16. Iowa Administrative Code rule 191—10.10(2)(b) states that applications for reissuance must allege facts sufficient to enable the Commissioner to establish that the basis of the revocation no longer exists.

17. IDR has withdrawn the Certificate of Noncompliance relating to Applicant, and Applicant has filed the application for reissuance required by Iowa Administrative Code rule 191—10.10(2)(a) and has met his burden of establishing that the basis for the suspension no longer exists.

18. Applicant should be issued a new resident insurance producer license.

IV. ORDER

IT IS THEREFORE ORDERED that:

- A. Brodie L. Thomas's Reissuance Application is granted and the administrative block is removed from his Iowa licensing record;
- B. Brodie L. Thomas's Uniform Application for Individual License Registration is approved;
- C. Brodie L. Thomas shall immediately be permitted to transact and participate in the business of insurance in Iowa; and
- D. Brodie L. Thomas shall refrain from any further violations and abide by all insurance laws in Iowa and all other jurisdictions.
