Pursuant to Iowa Code Chapter 522B—Licensing of Insurance Producers and Iowa Administrative Code rule 191—10.10, this matter comes before the Commissioner of Insurance upon an application by Marcus R. Wynn for the reinstatement of his Iowa resident insurance producer license.

I. PARTIES AND JURISDICTION

1. The Commissioner of Insurance, Doug Ommen, directly and through his designees, administers and enforces Iowa Code Chapter 522B—Licensing of Insurance Producers Act, and Iowa Administrative Code Chapter 10 — Insurance Producer Licenses and Limited Licenses pursuant to Iowa Code § 505.8.

2. Marcus R. Wynn (“Applicant”) is an individual with a last-known residence address of 705 E. Central Park Avenue, Davenport, Iowa 52803 and a National Producer Number of 18769291.

3. Applicant has filed an application with the Iowa Insurance Division (“Division”) for reinstatement of his suspended license and the Commissioner is authorized to issue this Order pursuant to Iowa Administrative Code rule 191—10.10.

II. FINDINGS OF FACT

4. Applicant is licensed as an Iowa resident insurance producer.

5. Applicant applied for a resident insurance producer license with the Division by submitting through the National Insurance Producer Registry a Uniform Application, in which he designated the Commissioner as an agent for service of process. Respondent's insurance producer license will expire on June 30, 2027.

6. On May 21, 2025, the Division mailed Applicant, by both restricted certified mail and by first class mail, a notice of intent to suspend his license if the Iowa Department of Health and Human Services ("DHHS") did not withdraw the Certificates of Noncompliance within 30 days.

7. On July 8, 2025, the Division issued an order immediately suspending Applicant's insurance producer license ("Suspension Order"). Reinstatement of the Applicant's producer insurance license was contingent upon DHHS withdrawing the Certificates of Noncompliance.

8. DHHS withdrew the Certificates of Noncompliance on July 15, 2025.

9. On July 17, 2025, Applicant filed an Iowa Insurance Producer Application for Reinstatement as required by Iowa Administrative Code rule 191—10.10.

10. The reinstatement terms of the Suspension Order have been satisfied.

III. CONCLUSIONS OF LAW

11. Iowa Administrative Code 191—10.10(2)(a) states that a producer whose license has been suspended by order may apply to the Commissioner for reinstatement of his or her license by filing an application for reinstatement.

12. Applicant has filed the required application for reinstatement.

13. Iowa Administrative Code 191—10.10(2)(b) states that the application for reinstatement must allege facts sufficient to enable the Commissioner to establish that the basis of the terms of the Suspension Order issued July 8, 2025, have been satisfied.

14. Respondent has filed the required application for reinstatement and has alleged facts that demonstrate that the basis of the suspension no longer exists. An order of reinstatement should be issued pursuant to Iowa Administrative Code rule 191—10.10.


IV. ORDER

IT IS THEREFORE ORDERED that:

- A. Applicant's resident insurance producer license is reinstated; and
- B. Applicant shall immediately be permitted to transact and participate in the business of insurance in Iowa.

IT IS FURTHER ORDERED that, pursuant to Iowa Code § 505.8(10), the one hundred dollar (\$100) payment remitted with the application for reinstatement for administrative costs shall be paid to the Iowa Insurance Division Enforcement Fund to provide funds for insurance enforcement and education.
